INFORMATION REGARDING LOT/HOME OWNERSHIP BEING IN THE NAME OF

A TRUST

As discussed at the Board of Directors' meeting on May 28, 2022, when property on Crowley Ranch is owned by a trust, there must be a "Statement of Authority" filed with the Association Secretary showing who is authorized to represent the trust. While this has always been a requirement, it has never been enforced. It has been ignored.

In order to follow the requirements of the Colorado Common Interest Ownership Act, the Colorado Nonprofit Act, the Crowley Covenants and our Bylaws, we are asking that trust owners comply with the following comments of the Ranch's new attorney.

"As discussed, the Association is able to ask that the trust or entity to designate in writing the name of the person who is authorized to act on behalf of the trust or entity. That natural person can vote and serve on the Board of Directors. In Colorado, the trust or entity will typically fill out a Statement of Authority which is recorded in the real property records. You could ask for a copy of the Statement of Authority from the trust or the relevant pages of the trust agreement that indicate who the trustee is that is able to act on behalf of the trust."

The Board of Directors cannot give legal advice on how to accomplish this task. Rather,

please consult with your family attorney, trust attorney or someone who can provide the above noted Statement of Authority. Chances are that you already have the document completed and filed with the proper authorities. Also, Colorado Revised Statutes Title 38-30-172 may provide some helpful information.

Therefore, in order to vote or run for the Board of Directors, please provide a signed copy of the Statement of Authority to the Crowley Ranch Secretary for inclusion in the Ranch files.
