

# 2022 SANCTION CONTRACT

## KANSAS PROFESSIONAL RODEO ASSOCIATION

THIS AGREEMENT made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ by and between the KANSAS PROFESSIONAL RODEO ASSOCIATION, here-in-after referred to as the "KPR" and \_\_\_\_\_, here-in-after referred to as the "Committee"

WHEREAS, the Committee desires to sanction a rodeo with KPR and it is therefore mutually agreed as follows.

- 1. For all rodeo committees, the communication between the KPR office is open all year, and especially during entries for any questions you may have to help us assist you in putting on the best rodeo possible.**
2. The rodeo secretary agrees to withhold 5% of the entry fees (EXCLUDING any added money), and \$11 per entry, to be paid to the KPR. The Committee or rodeo secretary will furnish the KPR office an emailed copy of the rodeo results within 24 hours of the completion of the rodeo, and the complete rodeo packet and money owed the KPR within 4 days after the last performance.
3. The Committee will endeavor to comply with ALL the KPR rules and regulations as set forth in the official KPR rule book.
4. The KPR agrees to furnish a listing of approved rodeos in its official publication.
- 5. All contestants who pay entry fees shall be entitled to 1 pass for themselves and 1 for their companion provided that the companion can show a current KPR Companion Pass, for the performance in which they compete.**
6. The Committee and furnishing stock contractor agrees to use the KPR Central Entry Office.
7. Entries may be limited, but all KPR members must be guaranteed a chance to enter the rodeo, but, not necessarily during the performance they desire, in order to keep the performances even. Entries need not be limited to KPR members only. This is done at the option of the stock contractor or Committee.
- 8. The Committee will have an AMBULANCE on the grounds for the duration of the rodeo (including slack). FAILURE TO COMPLY WITH THIS RULE WILL RESULT IN A \$500 FINE.**
9. In case of a rodeo cancellation, the person responsible for the cancellation will stand all expenses incurred by the KPR if the rodeo is cancelled after the books are closed.
- 10. The Committee will have a veterinarian on call during the rodeo and slack. FAILURE TO COMPLY WITH THIS RULE WILL RESULT IN A \$100 FINE.**
11. All attempts in keeping the ground the same for each performance and slack will be approved by the KPR judges judging the sanctioned KPR rodeo. The barrel racing director and/or alternate may also be included in the discussion in regards to the arena ground condition.
