KPRA LIABILITY WAIVER

Under Kansas law, there is no liability for an injury to or the death of a participant in domestic animal activities resulting from the inherent risks of domestic animal activities, pursuant to K.S.A. 60-4001 through 60-4004. You are assuming the risk of participating in this domestic animal activity.

WARNING - Inherent risks of domestic animal activities include, but shall not be limited to:

- (1) The propensity of a domestic animal to behave in ways i.e., running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them;
- (2) the unpredictability of a domestic animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
- (3) certain hazards such as surface and subsurface conditions;
- (4) collisions with other domestic animals or objects; and
- (5) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability.

AGREEMENT: In consideration for and as a condition of being allowed to participate and/or compete in all or any part of the any Kansas Professional Rodeo Association ("KPRA") approved event, I, in the event the participant is a minor, the consenting parent or

legal guardian, ("Signor") acknowledges and agrees to the following:

ACKNOWLEDGMENT OF RISK: The Signor acknowledges that rodeos are dangerous activities and that a person's participation in a rodeo in any capacity, either as a contestant, employee or volunteer, will expose the participant to a **SUBSTANTIAL AND SERIOUS RISK OF PROPERTY DAMAGE, PERSONAL INJURY AND/OR DEATH**. The Signor expressly acknowledges that participation in any KPRA approved event will involve such a hazard. All participants agree to assume such hazards and risks.

THIS IS A RELEASE OF LIABILITY. ALL PARTICIPANTS AND PARENTS ARE AGREEING TO RELEASE THE KPRA, ITS AFFILIATES, STOCK CONTRACTORS, AND/OR RODEO COMMITTEES FROM LIABILITY. PLEASE READ THIS PROVISION CAREFULLY.

The Signor, being fully aware that participation in any KPRA approved event will expose the participant to a substantial and serious risk of property damage and/or personal injury and/or death, hereby agrees release the KPRA or any and all Sponsors and (including their officers, directors, employees, volunteers, agents or affiliates) from liability for any and all property damage, personal injuries, or other claims arising from participant's participation in any KPRA approved event, including those that are known, foreseen and unforeseen, future or contingent, and includes claims, demands and liabilities arising out of the negligence of the parties so released. Furthermore, to the fullest extent permitted by applicable law, this discharge waiver and release also includes claims, demands and liabilities arising out of gross, willful or wanton negligence of the parties so released. This discharge also includes claims, demands and liabilities for indemnities and contributions arising from property damage, personal injury and/or death to a third party. In the event that any provision of this discharge, waiver and release is determined to be invalid for any reason, such invalidity shall not affect the validity of any of the other provisions, which other provisions shall remain in full force and effect as if this discharge, waiver and release had been executed with the invalid provision eliminated. The undertakings and covenants of the foregoing provisions shall be binding upon each contestant, all participants and parents, his or her heirs, legal representatives, successors, and assigns.

INDEMNIFICATION. Each contestant, all participants and parents agree to indemnify, defend, save and hold harmless including, without limitation, the KPRA and all event sponsors and affiliates from any and all claims, demands and liabilities for any and all property damage, personal injury and/or death asserted by a third party and arising from such participation in KPRA approved events.

COVENANT NOT TO SUE: The Signor covenants that the Signor shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the KPRA and/or any and all Sponsors (including their officers, directors, employees, volunteers, agents or affiliates) concerning, arising out of, or in any way related to the actions, causes of actions, claims and demands hereby waived, released or discharged by the Undersigned. If the participant is a minor, then the Signor covenants the same on behalf of the minor.

ASSURANCES: The Signor has full power, authority, capacity and right without limitation to execute, deliver and perform this Release, whether for himself/herself, or on behalf of his/her minor child or ward. The Signor further represents that the participant is in good health and has no medical, physical, or mental impairments or problems that would prevent him/her from safe participation in these event(s) or require special care, equipment, or attention.

EFFECT: This Release shall be binding not only upon the Signor but also upon the Signor's spouse, legal representative, heirs, successors and assigns. This Release has been carefully and fully read by the Signor and the Signor fully understands its terms and conditions and has voluntarily executed and delivered this Release.

I understand that by signing this Liability Waiver, I acknowledge that I have fully read the Liability Waiver and understand all of its provisions. I will be renouncing certain rights to seek recovery against the event organizers and sponsors in case of injury, etc., and specifically that I will be releasing all of the same from any potential liability for any injury that may occur, whatsoever. I agree to abide by the rules and regulations of the KANSAS PROFESSIONAL RODEO ASSOCIATION (KPRA) and not hold the KPRA responsible for any related incidents or accidents involving the KPRA. I hereby waive and release any and all claims against the KPRA, its officers, directors and employees. I give the KPRA permission to publish my name and monies won in the official association publication and on the association website. This provision shall be binding upon said member, his or her legal representative, heirs, successors, and assigns.
