District Profile: Khuzdar

Khuzdar District

Khuzdar district is located in Balochistan province of Pakistan, with its principal town being the city of Khuzdar. Previously, it was included in Kalat district but was given district status in 1974. It is bordered with district Kalat to the north, districts Jhal Magsi, Larkana and Nausharo Firoz to the east, districts Kharan, Washuk and Awaran to the west and district Lasbela to the South. The general character of the district is mountainous, consisting of numerous ridges and valleys. The prime hill ranges are Jhalawan, Moda, Pab and Kirthar. The total area of the district is about 35,380 km².

The district is administratively subdivided into the following tehsils:



According to the EMPIS Balochistan, in district Khuzdar there are 58 EPI centers. These comprise of 19 basic health units, 5 rural health centers, 2 hospitals, 30 DHO Offices and EPI centers Balabal and Sarej Gresha. The data reveals that the overall coverage of Pentavalent III in district Bolan is 52%. However, there are 46 health facilities with less than 80% Pentavalent III coverage. The lowest coverage is reported as 0% in 12 EPI centers, namely: MT Gaaj (DHO Office), MT DHO Office (Parko), MT DHO Office (Goniko Ward), DHO Office (Aranjee Masjid), DHO Office (Andraj), Faizabad 2-ORT (DHO Office), DHO Office MT (Sonaro), DHO Office MT (Koraro), DHO Office MT (Khand), DHO Office MT (D-NAL), DHO Office MT (Bhalonk), DHO Office MT (Badri).

LHWs Involvement in Routine EPI

The LHW MIS data reveals that there are only 7/58 health facilities in which 24 LHWs are attached. Therefore, the LHW coverage in the district is only limited to 12%.

The sub-optimal level of PENTA III coverage may be attributed to lack of LHWs attachment with the respective health facilities and lack of training in routine EPI. Moreover, lack of and delayed refresher courses in EPI are also noted as one of the contributing factors for updating the knowledge of LHWs in routine EPI.

The monitoring and supervisory role and capacity of Lady Health Supervisors is pertinent for effective service delivery by the LHWs. Therefore, lack of LHSs and lack of their capacity building in monitoring and supervision for routine EPI adds to the overall improved or poor EPI performance of the Khuzdar district.
