Use of “x” on scorecard means “did not finish.” It’s Ok to use in a team event if your ball doesn’t count. But generally, play it in. We have two RMGC web sites. Our main **RMGC website** (the one with a picture of a ball going into a hole) is used for social events, links to other sites, etc. The other is the “portal” - which is where sign-ups occur (Golf Genius). If you save the emails about “sign-ups,” you can use that email to cancel by doing a “REPLY.”
