- f) Kevyn agreed to head up altering our bylaws if this becomes necessary and estimated that it could take up to five months to complete the effort (primarily due to CLC being in the process of creating a new template and the potential for several iterations to attain approval).
- g) There are 96 Titans that are members of our club and approximately 40 of them golf with us. Board recommendation is that all Titans be a member of RMGC. We hope to meet with Bill Edwards on 5/17 after golf.
