II. Agenda

- a) Joe presented the September financial statement (attached at end of this document). SCA Finance Committee has indicated we could carry over whatever funds we have remaining as long as we spend them in 2022.
- b) There will be NO "RMGC Men's league play" on Wednesday, October 27. That time is reserved for the Member-Member tournament as is lunch for only those playing (which is paid for by the entry fees).
- c) Board agreed that any hole in one during Member-Member would not qualify for the Men's League hole-in-one.
- d) Board agreed that any new members as of Oct 1 (who are paid for reminder of 2021 and all of 2022) who paid their \$10 for hole-in-one insurance would get paid for a hole-in-one in 2021. But, they would have to pay another \$10 (if desired) for hole-in-one insurance for 2022.
- e) There will be an RMGC Men's League Team Event before the end of 2021 called the "Yellow Ball tournament." It will be similar to the "lone ranger"-format. Tom has purchased the balls for this tournament and will mark them so they are unique. Should be a fun time! The "yellow ball" will be assigned to be played by one person per hole, with 2 players using the yellow ball four times and two using it five times. Teams who are able to turn in the yellow ball (that is, not lose it!) to the scorer's table at the end of the round will qualify for that day's prize money.
- f) RMGC Participation Cup tournament will be a scramble played on Friday, 10/29. All invited folks need to kick in \$10 for "prize money." Approximately 20 members qualified and will receive an email shortly.
- g) Christmas Party: Gary presented information on alternatives for dinner, appetizers, etc. Price per person will be approximately \$50. Timeframe is approximately 6pm-10pm. The Board approved dinner choices, appetizers, and drink tickets. Gary was able to negotiate getting the room for free, and reduced prices for drinks. Board approved payment for DJ out of funds remaining in 2021.
- h) We will solicit renewals / new members starting November 1.
- i) Gary plans to keep the social and membership duties for 2022 with assistance from Mark Bailey on social duties. Mark will assist, but *not* be a member of the RMGC Executive Board.
