- **Approval of Treasure's Report** (Dave Weil): Dave sent out the July financial report.
- **Social Membership Officer** (Mark Bailey):

 - **Dues increase, it was decided and agreed to by the RMGC Officers present to the following increase in dues per member.**
 - SNGA cost=\$37 (increase of \$1)
 - RMGC cost increase=\$63 (\$33 increase)
 - Total for membership=\$100
 - HIO club=All members are included in the HIO program. The HIO payout will be increased to \$300 per HIO. There will be no payout at the end of year. The money left over if any will be used for club social events.
 - **Grand Total=\$100**
