Approved applicants and dependents must inform TPC seven days in advance of their request to have the visa affixed upon their arrival at the airport under normal travel conditions or at the Immigration Bureau in Bangkok.

- Elite Superiority Extension 20-year residence visa for individuals who pay a one-time fee of THB 1 million including VAT (approximately USD 32,000)
