

Voting in the 2025 Sewer Board Elections

HOW DO I GET A BALLOT AND VOTE

Montana residents who live and vote in the Sewer District

- Make sure you are registered to vote and in “active status” in the Sewer District.
- If you are registered to vote and active on the rolls, a ballot will automatically be mailed to you at the address within the Sewer District on file with the Park County Elections Office.
- Return the ballot by mail to the Park County Elections Office (confirm first class postage)
- Ballot must be RECEIVED BY TUESDAY, MAY 6, 2025.
 - Allow 7 days for postal mail.

Montana resident cabin owners who live outside the Sewer District and are registered to vote somewhere else in Montana (i.e. do not vote in the Sewer District / Park County)

- Make sure you are registered to vote and in “active status” in your home precinct.
- Call the Park County Elections Office at 406-222-4110 to request a ballot BY APRIL 11, 2025.
- Return the ballot by mail to the Park County Elections Office (confirm first class postage)
- Ballot must be RECEIVED BY TUESDAY, MAY 6, 2025.
 - Allow 7 days for postal mail.

Non-resident cabin owners of taxable real property within the Sewer District who live and vote in their primary home state of residence (i.e., seasonal cabin owners and owners of vacant land who pay property taxes to Park County but Montana is not their primary home)

- Call the Park County Elections Office at 406-222-4110 to request a ballot BY APRIL 11, 2025
 - Tell the county you are a non-registered landowner and you are requesting an absentee ballot for a water/sewer district.
 - You will be asked to complete and submit a form + proof of property ownership like the most recent property tax bill
 - Form is called: [Nonregistered Elector Mail Ballot Request Form for a Water and/or Sewer District](#)
- Return the form + proof of property ownership to the Park County Elections Office BY APRIL 11, 2025.
- Return the ballot by mail to the Park County Elections Office (confirm first class postage)
- Ballots must be RECEIVED BY TUESDAY, MAY 6, 2025.
 - Allow 7 days for postal mail

EXTRAS

- **If your property was included in the Silver Gate Petition for Exclusion, you are no longer in the Sewer District and cannot vote.** Call Park County Elections Office to confirm whether or not your property is still in the Sewer District at 406-422-4110.
- **Own more than one parcel in the District?**
 - Each parcel is entitled to one ballot but each voter is only allowed one ballot. So consider a spouse or designated agent to vote the additional parcel/s.

Voting in the 2025 Sewer Board Elections

- Contact Park County Elections Office to request the Form: [Nonregistered Elector Mail Ballot Request Form for a Water and/or Sewer District](#) to identify the person designated to vote by the owners.
- Return the form + proof of property ownership to the Park County Elections Office BY APRIL 11, 2025.
- Ballots must be RECEIVED BY TUESDAY, MAY 6, 2025.
 - Allow 7 days for postal mail.
- **Property owned by more than one person?**
 - A designated agent can vote on behalf of all owners.
 - Contact Park County Elections Office to request the Form: [Nonregistered Elector Mail Ballot Request Form for a Water and/or Sewer District](#) to identify the person designated to vote by the owners.
 - Return the form + proof of property ownership to the Park County Elections Office BY APRIL 11, 2025.
 - Ballots must be RECEIVED BY TUESDAY, MAY 6, 2025.
 - Allow 7 days for postal mail.
- **Property owned by a corporation or company?**
 - An individual representing a corporation or company that owns taxable real property within the Sewer District can vote.
 - Contact Park County Elections Office to request the Form: [Nonregistered Elector Mail Ballot Request Form for a Water and/or Sewer District](#) to identify the person designated to vote by the owners.
 - Return the form + proof of property ownership to the Park County Elections Office BY APRIL 11, 2025.
 - Ballots must be RECEIVED BY TUESDAY, MAY 6, 2025.
 - Allow 7 days for postal mail.
- **Property owned by or held in a trust?**
 - A designated agent can vote Properties held in trust within the Sewer District.
 - Contact Park County Elections Office to request the Form: [Nonregistered Elector Mail Ballot Request Form for a Water and/or Sewer District](#) to identify the person designated to vote by the owners.
 - Return the form + proof of property ownership to the Park County Elections Office BY APRIL 11, 2025.
 - Ballots must be RECEIVED BY TUESDAY, MAY 6, 2025.
 - Allow 7 days for postal mail.
