Marine Claim Processing Challenges

- Inconsistent approach to claims management throughout the marine industry. Difference in the way claim documentation is stored and how claims are presented.
- Excessive time to finalize and settle marine claims. This leads to increased costs and interest on claims but also leads to frustration from the stakeholders involved ("You are asking for documentation for a claim which is 5 years old.... Why has this claim not been resolved yet?".
- Too many stakeholders (Owners, Managers, Insurers, Brokers, Lawyers etc.) not enough accountability.
- Time to assess and reassess a claim's status. This leads to further costs and time wastage.
- Quantum of claims are often an afterthought leading to a broad brush approach to settlement.
- Lack of focus and attention on the claim and the issues which need to be addressed to get the claim proven and settled.
- Increasing costs (lawyers, claims handing companies etc.)
- Personnel change often leads to inconsistency of handling the claim

What if there was a claims management software/web based application that could manage a marine claim from start to finish, in real-time, with end to end user functionality and accountability which would save time, reduce costs of managing claims and ensure accountability across all stakeholders?



Navis[™] is a cloud-based marine claims application designed to be used by all stakeholders of a marine claim. All claims are accessed in real-time allowing the user to monitor the status of the claim.

Each individual claim is assigned its own unique reference and can be monitored via the Dashboard. The Dashboard provides the user with a status and timeline of the claim. The Dashboard also provides interest calculations in real-time, as well as showing applicable time limits and "days to go".

Navis[™] makes reporting to stakeholders easy with its unique streamlined/standardised reporting templates. Reporting templates can be generated with a click of a button for both Quantum / Liability and status of the claim. The user can also choose which specific data to report.

Navis[™] also includes a documentation management system for both Quantum & Liability. The user can upload and assign documents to each item of claim. Once assigned, and the claim finalised an auto-generated claim bundles and claim schedules can be produced. Users can also send links to stakeholders for them to upload documentation both internally and externally. Documents related to liability can also be managed within Navis[™] and the user can auto-generate document list (for use internally and externally) as well as liability document bundles
