The 1st farm to be preserved in the program was the **Tuel & Tingle** property in our very own Newlin Township. Many of us know the farm right out of Unionville on Rt 842. The Tuel & Tingle family operated their nursery business until they sold to **Rose & Michael Peters** in recent years. The Peters have renamed the farm **FOUR BELLS**. They are currently updating the farm and have their farming plans to support the local agriculture economy.

## *Oliver P. Bass named new President of Natural Lands*

**Oliver Bass** has dedicated much of his career to conservation. Over 21 years at Natural Lands he led the organization's communications efforts and grew its mission commitment to connecting people to nature, greatly expanding participation in public programs and volunteerism, elevating the organization's public profile, and launching a new initiative to improve equitable access to green spaces in underserved communities of our region's suburbs. As a result, visitation to preserves has grown by 220% to 125,000 people a year; more than 100 programs each year are attracting 5,000 participants; the Force of Nature program has graduated 200 volunteers; and overall volunteer participation has doubled to more than 5,000 hours annually. ## *Brianne Zanin, New Director of Open Space Preservation for Chester County*

Chester County Commissioners **Michelle Kichline, Kathi Cozzone and Terence Farrell** announce the appointment of **Brianne Zanin** as Director of Chester County's Department of Open Space Preservation, effective February 4, 2019. Zanin, 34, moves to this new role following six years as Deputy Director of the County of Maui Department of Parks and Recreation.

As Director of Open Space Preservation for Chester County, Brianne will lead the department in the strategic effort to preserve agricultural land, municipal parks, trails, greenways, and other land preservation projects. During her time with the County of Maui Department of Parks and Recreation, Brianne was responsible for 142 county parks spanning more than 2,500 acres, a \$30 million annual operating budget and \$12-\$40 million capital budget, and overseeing the performance management of more than 275 full-time and 400 part-time employees.

Zanin takes over the leadership role from **Bill Gladden** who was named Executive Director of French & Pickering Creeks Conservation Trust in August.
