These Terms of Service set out the agreement between you and TheNurseMall.com regarding how you can use TheNurseMall.com Service and what responsibilities you and TheNurseMall.com have to each other. These Terms of Service contain important information regarding your legal rights.

1. Eligibility, Acceptance of Terms, and Registration

- 1.1. Eligibility. TheNurseMall.com Service is for individuals who are 18 years of age or older and reside in the United States (including its territories and possessions). You may not access or use TheNurseMall.com Service if you are outside of the United States (including its territories and possessions) or are barred from receiving TheNurseMall.com Service under these Terms of Service or applicable law.
