CHIEF'S MESSAGE

The primary purpose of this report is to keep the community informed as to the activities and progress on major programs or objectives.

Personnel:

Per our current roster, we have 56 active members, 26 Support Group, of which 13 are in the medical cadre. We currently have 21 rostered Firefighters which include, one Chief/Paramedic of the Department, one Assistant Chief, one Division Chief of Special Operations, one Battalion Chief, 2 part-time Captain Paramedic, one Lieutenant.

Of our fire personnel, we have 15 members that can drive and operate all equipment.

Recruitment and Retention

To recruit personnel, you must create an interest to join, then allow members to take ownership of the Fire District, in a way make it theirs. Something that garners pride, self-satisfaction and achievable goals, with a focus on capability and professionalism.

As the Fire Chief, as I see it; whether a member is in the Support Group or on the Fire Side, a sense of belonging, pride in ownership must be present to elevate any Emergency Response Service to the current standards required to operate. That all members must dropped the moniker of 'Volunteer" and take on the roll as a professional.

Whether directing traffic, responding to a medical emergency, responding to extinguish a fire, or conducting any type of rescue, it does not matter. This requires a professional, one who is

knowledgeable, with confidence and competence in their skill and knowing they can bring a complex incident to resolution.

We have been working on the restructure of the Fire District, to provide personnel with ownership, building on their pride of service and increasing the talent of which they respond to the community to provide emergency services.

Assignments have been made and tasks delegated to Fire Personnel.

Division Chief Chris Dillender will be taking on the task of Special Operations. His assignment is identify equipment and training requirements for all forms of rescue, to include technical rope rescue, Auto Extrication. Hazardous Environment Entry. He will develop policy, conduct training, identify the rescue needs of the community.

Firefighter Tony Christensen, will assist in the development of special operations, as will Firefighter Heide Glockner.

Firefighters Trevor Dillender and Randy Combs are responsible for Facilities and Fleet Management and will coordinate with the Capital Improvement Group for facility needs and repairs.

Firefighter Heide Glockner is the Fire District Outreach Coordinator. She will Assist Community groups in the missions to serve the community, such as Communications and events, special projects, community service.

Firefighter Austin Eby will be our Emergency Medical Coordinator, he is tasked with EMS Equipment ordering, development and delivery of EMS Training.

In the upcoming months, I will be looking to expand the roll of the Support Group, to include Rescue Group which will assist personnel in the technical rescue operations, deployment of and operation as haul teams, for technical operations. I hope to also increase the Medical Cadre Operations to include Community Medical Welfare Checks. holding blood pressure clinics and providing CPR Training tom the community.

Department Training and Safety:

As we move on into 2025, there will be changes to required attendance for training.

For Firefighters there will be mandatory training requirements. All fire personnel, will need to attend one mandatory training Tuesday per month. with one mandatory Training Saturday per quarter.

The IDLH Academy at El Dorado Hills Fire has been canceled, all members who were assigned to that academy will attend the IDLH Academy to occur Garden Valley, starting next month.

We recently completed OSFM Driver Operator I-A. which will increase the availability of personnel capable and qualified to drive and operate Firefighting Apparatus. We have Driver Operator I-B, (Pump Theory) starting January 21. 2025

Training to be scheduled: BLS Provider/Train the Trainer

Logistics:

The wharf Hydrant on the south east corner of the fire station required repairs to the supply line underground.

We will be scheduling respirator fit testing in February. All members requiring respirator fit testing will be assigned a day and time which. they will undergo testing at Georgetown Fire Station 61.

Interlocal: Nothing to report at this time.

Legislative: Upcoming CALOSHA regulations to be released, information to follow

Grants: We submitted a FEMA SAFER Grant Proposal for hiring of personnel. Two FEMA AFG Grants, one for the purchase of a Type 6 Fire Engine, one AFG Regional Grant for the purchase of a breathing air compressor. We are in constant search for all grant opportunities.

Apparatus: All Fire Apparatus were inspected by Jason Warden of Stretchfab Truck Repairs. All of our Firefighting assets are capable of operating as necessary in the event of emergency for which they are designed. Over the years, the apparatus has fallen into serious neglect, now requiring considerable maintenance repairs.

Rainbow Trout Stocking at Finnon Lake Reservoir!

On January 14, 2025, the California Department of Fish and Wildlife (CDFW) provided a fish stocking at Finnon Lake Reservoir. The Nimbus Fish Hatchery in Gold River, CA, (between Folsom and Sacramento), played a crucial role in this event, providing 400 pounds of rainbow trout, approximately 800 fish in total. Some of these trout were impressive, measuring up to 14 inches in length!

This stocking event is part of CDFW's ongoing efforts to enhance recreational fishing opportunities and maintain healthy fish populations in California's waterways. The Nimbus Fish Hatchery, one of the 21 fish hatcheries overseen by CDFW, is known for raising Chinook salmon

and steelhead, but this recent stocking of rainbow trout is a treat for local anglers.

Finnon Lake Reservoir, located in Placerville, CA, is a popular spot for fishing, boating, picnicking, and other outdoor activities. The addition of these rainbow trout is sure to attract fishing enthusiasts from near and far, offering a chance to catch some beautiful fish in a picturesque setting.

The Nimbus Fish Hatchery plays a crucial role in preserving the populations of Chinook salmon and steelhead trout. Introducing the California Inland Recreational Angler Survey (CIRAS)

The California Department of Fish and Wildlife (CDFW) has launched an innovative new program called the **California Inland Recreational Angler Survey (CIRAS)**. This web-based platform is designed to gather valuable data from anglers about their fishing trips, providing immediate access to aggregated sport fishing data through an interactive "Ready to Fish" dashboard.

What is CIRAS? CIRAS is a crowdsourcing platform that allows anglers to submit information about their fishing experiences. This data includes details about the species caught, catch rates, size distributions, and the time of year when fish are most active. The platform aims to give anglers a user-friendly experience while contributing to scientific research and helping CDFW better manage California's fisheries.

Why is CIRAS important? By participating in CIRAS, anglers can help CDFW understand angler preferences and the performance of fisheries. This information is crucial for making informed decisions about fish stocking, habitat conservation, and other management practices. Additionally, anglers can access data submitted by others, helping them plan their next fishing trip more effectively.

How does CIRAS work? Anglers can access the CIRAS platform online and submit their fishing data. The platform is currently available for waters within CDFW's North Central Region, which includes counties such as Alpine, Amador, Butte, Calaveras, Colusa, El Dorado, Glenn, Lake, Nevada, Placer, Plumas, Sierra, Sutter, and Yuba2. CDFW plans to expand the platform statewide in the future.

What's next for CIRAS? As the pilot phase continues, CDFW will gather feedback from anglers and make improvements to the platform. Eventually, CIRAS will be available to all California counties, providing a comprehensive database of fishing information for anglers across the state.

Get Involved! Anglers are encouraged to participate in CIRAS by submitting their fishing data and exploring the information available on the platform. By contributing to this program, anglers can play a vital role in the conservation and management of California's fisheries.

For more information about CIRAS, visit the CDFW website. Finnon Reservoir is a listed location in the CIRAS app, so please document your fishing experience online when fishing at Finnon Reservoir.
