 - Justin contacted the HOA insurance and they do not feel comfortable with hunting happening on the common space of the HOA.
 - Justin motion to not allow any hunting to take place on HOA property. Josh second this motion

- 5. Business Arising/New Business
 - Discussion future vision of the Board With the amount of new board members, Justin proposed for board members to brainstorm ways for the future of the board. We, as a board, will bring these ideas to the January meeting.

 - Board feels this violates privacy of board members
 - Joe motions to create a unified email for the HOA. Josh will handle the creation and operations of the new e-mail. This will allow residents to send an e-mail to one e-mail address. That e-mail will be forwarded to all board members.

 - A sign asking people, "Please do not drive into the park" was lost due to flood or vandalism damage.
 - Janna noticed that the signs have been gone for a while
 - It was discussed to buy new signs to put up to bring awareness that the park and creek access are for residents only.
 - Brainstormed different sign sayings
 - Justin motioned to buy two "Private Property No Public Access Violators" signs and two green stakes from Lowes. Justin and Joe will install. Katie seconds the motion

- Replace dog signs
 - Justin will take a look and will discuss it in the January meeting
 - Discussed installing dog poop bag dispenser. No one seemed to be in favor. It is not worth the cost.
- o Encroachment on privately-owned lots
 - Janna mentioned there has been a lot of driving in the backyards of the south properties. Janna reached out to the township and found that there was no public easement in the back properties. Individual properties owners need to give access.
 - The only property easement that should be discussed during board meetings should be the property owned by the North Middleton Association.
 - Justin motioned to reach out to the lawyer about easements. No one seconded.
 - Discussed that the board is in charge of fixing lawn care. It
 would be the responsibility of the HOA to fix the lawn, but the
 association will/can charge the individual for the damage that
 was done.

6. Committee Recaps

- Finance Committee
 - Several large past-dues are now caught up
 - We still are not able to accept credit cards due to the association not having credit
 - Justin and Katie talked with Members 1st Credit Union
 - Members 1st Credit Union has an ACH program home owners could set up an automatically withdraw from their bank accounts to pay their HOA monthly fee. HOA members would have to fill out a one-time form to enroll. The money would then be transferred into the North Middleton Estates account. It would cost the association \$300 per year. We will also earn more interest on our association accounts at Members 1st.
