COMMITTEE REPORTS

Recreation – Shana mentioned that she would try to plan an even for the community to take place in September.

Budget/Finance/Delinquent Accounts & Notices - Jan distributed an updated list of past due accounts. Progress in collecting on these accounts continues to be made. The 5 accounts with the highest past due balances will soon receive a letter informing them that if payment is not made in the immediate future the accounts will be referred to our attorney.

Publicity & Communications – We determined that the date for the annual community yard sale

will be May 20, 2023. This will be publicized as we get closer to the event.

Architectural & Maintenance – Jan does not yet have a mulching date from our landscaper but will communicate once it is received. Jim mentioned that one homeowner had added a comment on their annual meeting ballot suggesting that we might consider going without mulching this year as a cost saving measure. The Board decided that foregoing mulching was not in the best

interest of the appearance of the community and it will take place as usual.

Jennifer provided some information on mailbox repair/replacement and commented that we could replace the pedestals rather than the entire mailboxes at a significantly lower cost. The

issue of mailboxes will continue to be considered by the Board going forward.

Jordon mentioned that he had found a fairly deep in the grass near the bottom of the driveway adjacent to 49 Partridge. This may be a residual impact from when that area was dug up for utility

work previously. Jim will look into it and fill it as needed.

Dogs without leashes and not under control of the owners continue to be a concern. This is a violation of both Township Code and the Association By-Laws. Two residents were identified as

repeat offenders in this area and letters will be sent out.

Attorney Update - Our attorney has provided a written response to the questions posed in an earlier meeting. These responses are in the process of being reviewed.
