Tracy called the meeting to order at 6:39.

Open Floor: (1 member in attendance)

- Resident brought quote from John Gleim on Drainage issue behind houses 1-15 Partridge (first building). After heavy rains, water runs down higher yards onto patios.
 - Proposal #2 would probably be best—have water run into storm water drains into the street;
 upsize pipes.
 - o Proposal #1—fewer supplies and lower cost; dig up pipe and replace; more time consuming.
 - o Proposal #3—put drainage grates outside patios; shape yards down into them.
 - New paving would make it higher.
 - Next building has same problem (last four, according to Tracy); ground has settled and sidewalk sank with the ground and is exposed.
 - Could be done this year. Seeding would be done. Want to avoid winter mud pit. Perhaps early spring instead. Would price change?
 - o Jason will have them come back and look at building 2.

Paving update

- Randolph got the verbal ok. No money has been given to them yet. Waiting on weather to cooperate
- They are going to mill some areas.
- Randolph has 2 year warranty.
- o Gleim \$6,500 higher.

 Approval of meeting minutes from 10/9/12 — Motion was made by Katie to approve. Seconded by Tracy.

Architecture Issues – Bea

- o Email from 114 Heron (Tim Keasling). Wants to enclose his patio like 38 Partridge.
- o 132 Partridge spouting falling off. Rental unit. Landlord is Dennis Kelleher.
- o Permission not needed to get new roof if not changing color.

Maintenance Issues

- o Juvenile probation called about the kids caught at the park. They are doing community service and restitution.
- o Front entrance perked up a little bit—dead tree out.
- New flag and light bulb to be put in.
- o Email from Kimsan Ting requesting two trees be replaced in community area behind them and one in front of the house (38 Partridge).
 - Residents who paid to replace trees should be reimbursed for what it would cost the HOA to replace one now.
 - Tracy asked Jan to get her a list of those who replaced trees on their own and list of missing trees. Tracy will let him know it will be done in the spring.

Financial Report - Katie

- o Four people taken to DJ last month (nothing gained); going for five tomorrow.
- o Maybe find a better way other than filing with the district justice (lose money when filing). Residents get a certified letter from DJ.

- Tracy did not get to look into the park gate issue.

- o Judy has list of contact information for booklet. Katie will provide name and house numbers.
