New trees for some affected residences are in the planning for Spring planting. We also had some unstable limbs removed from trees in the park to eliminate potential future hazards, and we have signed a contract to have the fir trees along Spring Rd treated in the Spring for needlecast disease.

You may have noticed the color blue in the green grass! We've had some caps to water (shut-off) caps replaced and painted so they will not be a tripping hazard.

We have been working to replace **street lamps** that are not functioning. If you see that a lamp is out, you can note the number on the pole and call 1-800DIAL-PPL (1-800-342-5775) to request a new light.

- •dogs acting aggressively—please be sure your dog is secured when out and about

- •trash blowing around—please be sure your trash is bagged and inside your toter (We understand that recycled items may be more difficult to control.)
- •leaving trash cans/toters in front of homes—our Covenants specify that these should be stored "at the rear of each townhouse" (or, we would suggest, "out of sight" when access to the "rear of the townhouse" is not reasonably feasible). Article II, Section 2, (l)
- •vehicles crossing private lots—please obtain permission to cross your neighbors' lots
