

evening's activities was a 50/50 raffle, a fashion show, and silent and live auctions.



# What is a Liquid Facelift?

We asked Local  
Board-Certified Dermatologist,  
Ann Zedlitz, M.D. "Dr. Z"

It's only natural to want to look and feel our very best but taking weeks off for cosmetic surgery isn't always possible. The liquid facelift offers patients rejuvenation with minimal downtime.

Dr. Z is here to break down the ins and outs of the trending liquid face lift, which involves injecting dermal fillers into the skin versus surgically lifting it.

## What does a Liquid Lift involve at your office?

A liquid facelift involves injecting dermal fillers into the skin to plump up or re-volumize the skin. It differs from a surgical facelift in that it does not involve cutting into the skin. My go-to filler for re-volumization and structure is Radiesse. Sometimes I will finesse the area after structure is laid with a hyaluronic acid filler such as Restylane or Revanesse.

## Who is a good candidate, generally speaking?

The ideal candidate for a liquid facelift is someone with mild to moderate wrinkles and experiencing sagging of the skin. If you have a lot of loose skin a surgical facelift might be a better option for you. Around age 35 is when most patients begin to see the first signs of volume loss. It is very important to not overfill. I always tell my patients, "If you can tell you have had something done, then I haven't done my job." A natural result is always my end goal for every patient.

## Is there any downtime involved?

Swelling from a liquid lift usually goes down within the first 48 hours and possible bruising may take 3 to 5 days to subside. For my patients, I have them stop any NSAIDS, aspirin, and certain vitamins one week prior to the filler treatment to reduce the risk of bruising. Patients should avoid heavy exercise for 24 hours post filler treatment and try to sleep elevated to help reduce swelling.

## What is the typical upkeep?

I recommend that all my patients come in for a two-week filler follow up appointment. At that time, after pictures are taken, I decide if the patient may need a little more. Less is more in my book.

Typically, a liquid facelift will last about a year, and touch up filler treatments are recommended at that time. Most patients will need 25% of what I used initially to fill the face as maintenance each year, depending on the patient's age and volume correction.

# Get Growing, Ascension!

## Sweet Potato Seed Potatoes Available through the LSU AgCenter

As a service to the residents of Louisiana, the LSU AgCenter's Sweet Potato Research Station produces foundation sweet potato seed annually. The Sweet Potato Research Station is located in Northeast Louisiana near Chase. It is the only facility of its kind devoted solely to sweet potato research. These seed potatoes are to be bedded in the row to produce "slips" or cuttings, which are then transplanted to the field to produce the crop. All varieties are certified to be free of viruses. The varieties available for purchase this year are Beauregard B-63, Beauregard B-14, Evangeline, Orleans, Bayou Belle, Bellevue, Bonita, Muraski,

Porto Rico, Sakura, and Burgundy. The top two varieties recommended for our area are Beauregard B-63 and Evangeline. Additional variety information can be found on the Sweet Potato Research Station website - [www.lsuagcenter.com/portals/our\\_offices/research\\_stations/sweet-potato/](http://www.lsuagcenter.com/portals/our_offices/research_stations/sweet-potato/).

The cost of a 40 pound box of seed potatoes is \$18.50 for Beauregard (B-63 and B-14) and Evangeline; and \$25.00 for all other varieties. Please contact LSU AgCenter Agent Mariah Simoneaux at [MJSimoneaux@agcenter.LSU.edu](mailto:MJSimoneaux@agcenter.LSU.edu) or (225) 621-5799 for more information or to place an order. All orders should be placed by



January 6, 2023. Potatoes will be ready for pick up in

February/March.

Sweet potatoes have a long history in Louisiana and have been grown commercially since the early 1900's. As home gardens have increased in popularity over the last several years, interest in growing sweet potatoes on a small scale has also increased. The LSU AgCenter has an excellent publication, "Growing Sweet Potatoes in the Home Garden" that gardeners can follow to produce their own sweet potato crop. Last year a

group of Ascension Master Gardeners grew sweet potatoes following the publication step by step. From two small, raised beds the group harvested over 150 pounds of potatoes. The project was a great success! To find a copy of the publication search the LSU AgCenter website for the title or contact the Ascension Parish LSU AgCenter Office.



# YOUR ESTATE MATTERS

## THE TOP 7 THINGS TO DO WHEN YOUR SPECIAL NEEDS CHILD TURNS 18 IN LOUISIANA

In Louisiana, when a person turns 18 years old, he or she is legally considered an adult and is presumed to have the capacity to marry, vote, enter into contracts and do all the things that adults can do. Some individuals with disabilities will be able to do these

things without any assistance, while others may need support in navigating the “adult” world. And then, there are others who may never be able to do these things on their own.

When a disabled child is in school and qualifies for special education services, that child is “entitled” to those services. There are no waiting lists. Local school systems are the single agency that coordinates special education services. This single point of service coordination does not exist in adult services and services in the adult system are usually not entitlement based.

Since there is no single source to tell you what you need to do when your special needs child turns 18, we have created a list of the most common things you should consider. While this list isn’t exhaustive and not everything on the list may apply to you and your child, we hope it will be a good place to start.

**1. Decide if your child should apply for Supplemental Security Income (SSI).** SSI is a federally-funded, needs-based disability program for adults and children which provides monthly cash

benefits. The applicant must meet disability and income requirements to qualify. You can apply as soon as the month after the child turns 18. If your child turns 18 on the 1st of the month, file that month. An article from the Aging and Disability Resource Center for Dane County, Wisconsin provides an excellent guide to when and how to apply for SSI for your child. The article can be found on their website.

**2. Get a valid state ID and register to vote.** Once your child turns 18 years old, he or she will need proof of identification for many things, including setting up a bank account or getting a job. If your child will not be getting a driver's license, you will need to obtain a Louisiana ID card. You can visit your local Office of Motor Vehicles to obtain an ID card. You can find the information you will need to obtain an ID card and register to vote on the OMV website.

**3. Decide if you should apply for Medicaid.** If your child receives even \$1 per month of SSI, he or she will be automatically eligible for Medicaid, a program funded by the federal and state governments. Medicaid pays for health coverage for people with disabilities. However, even if he or she does not receive SSI, he or she may qualify for Disability Medicaid in Louisiana. You can access information about Disability Medicaid at the Louisiana Department of Health's website.

If your child isn't already receiving services through a Medicaid Waiver and/or is not currently on a waiting list for a Waiver, decide if your child should be screened for one. Medicaid Waivers can provide services and supports to assist individuals with disabilities with their needs at home and in the community.

**4. If your child is a male, he must register with the Selective Service.** Men with disabilities still need to register with the Selective Service System. Almost all male U.S. citizens and male immigrants who are 18 through 25 are required to register with Selective Service. The easiest and fastest way to register is to register online.

**5. Consider having your child sign powers of attorney naming you as the Agent for financial and health care decisions.** If your disabled child has legal capacity, when he or she turns 18 consider whether you should consult with an attorney about health care directives and a

financial power of attorney so you can assist your child with financial and/or health care decisions.

**6. Discuss whether or not guardianship is appropriate.** If your child does not have the ability to understand or execute legal documents, it might be necessary to become your child's guardian (what we call a “curator” in Louisiana). You should contact an attorney who practices “interdiction” law in Louisiana to discuss whether a guardianship (curatorship) should be started. If your child is under 18, in Louisiana you can apply to a court to become his or her “continuing tutor.” While similar to an interdiction, the continuing tutorship might be a less difficult and cheaper process. Make sure you start this process well before your child turns 18 as it may take months to complete, and if your child turns 18 before it is complete, you will then have to use the interdiction process.

**7. Meet with an estate planning attorney to discuss whether you should have a Special Needs Trust to hold your child's inheritance at your death.** If you believe that your child will require Medicaid, SSI, or other governmental subsidies, discuss a Special Needs Trust (SNT) and/or an ABLE account. These tools can prevent Medicaid and SSI inancial disqualification. Further information about SNT and ABLE can be found online. Don't forget to ask other family members if they intend to leave anything to your child at their death. Often, well-meaning grandparents leave a gift at their death to their grandchild that causes SSI and/or Medicaid disqualification. An estate planning attorney with knowledge of special needs planning can assist in making sure everyone's plan for your child protects their vital benefits.

With the above information, you've got a great start on what to be aware of and what steps to take to ensure your special needs child is ready for adulthood. And when in doubt, know that you can get help from qualified professionals, like estate planning attorneys, who can help guide you through the process.

# FINANCIAL FOCUS

## Are you ready to 'unretire'?

Have you recently retired but are now thinking of going back to work? If so, you aren't alone, as many people are choosing to "unretire." But if you do reenter the workforce in some capacity, what opportunities might be available to you? And how will your renewed employment affect your financial outlook?

For starters, though, what reasons might motivate you to go back to work? For many people, the primary cause has been inflation, which has presented a huge challenge to retirees living on a fixed income. In addition, the volatile financial market of 2022 caused many people's investment portfolios to decline in value — a real problem for retirees who needed to start selling investments to supplement their income.

But non-financial factors could also be driving you to unretire. Like other retirees, you may miss the chance to use your work experience to engage with the world, and you may miss the social interactions as well.

In any case, if you do decide to rejoin the working world in some fashion, you may have several options. For example, if you enjoyed the work you did for your former employer, you might want to see if you could go back on a part-time basis. Or you could use your skills to join the "gig" economy by doing some consulting or freelance work in your former industry. You might also consider going to work for a nonprofit organization, as many of these groups lost employees

during the height of the COVID-19 pandemic and are now facing labor shortages.

Going back to work, even part time, can improve your cash flow, which helps cover the cost of regular expenses. Furthermore, the added income can possibly help you delay or reduce withdrawals from your investment accounts. And it's important to increase the longevity of these accounts considering you may spend two, or even three, decades in retirement. (Once you turn 72, however, you will have to start withdrawing certain amounts from your 401(k) and traditional IRA.) But your earnings can affect another source of your retirement income — your Social Security benefits.

If you return to work before your "full" retirement age, which is likely between 66 and 67, the Social Security earnings limit in 2023 is \$21,240. For each \$2 earned over that amount, Social Security will deduct \$1 from benefits. If you reach your full retirement age in 2023, the earnings limit is \$56,520; Social Security will deduct \$1 from your benefits for each \$3 earned over this amount until the month you turn your full retirement age. But in all future years after you've reached your full retirement age, you can earn as much as you want without losing any benefits. Social Security will then recalculate your payments to give you credit for the months your benefits were reduced or withheld due to your excess earnings. Be aware, though, that your earned income can potentially result in higher taxes on your Social Security benefits at any age.

Returning to work can be rewarding, both financially and emotionally. And you may get more out of the experience when you're aware of the issues involved.





# Jammin' with Goosie

## A Path Well Traveled

From the entrance gate the first one-hundred yards of the old logging road kinda looks the same as it did some thirty years or so ago. The loggers of that time had deposited some large limestone rocks at its beginning since that portion of the road was a low lying area. That particular stretch has a very solid bottom and basically stays under water with the exception of drying up during very dry spells that occur from time to time. At times I have driven down the old road with my truck or ATV for work related issues or to fish the gravel pit at the end of the trail, but if my memory serves me correctly, I have never removed any game out of there by the use of a vehicle. Believe me when I tell you that there have been many wild creatures carried out that stretch of right of way by this old boy in the last thirty nine years. The list includes several hundred squirrels, at least fifteen or more fine gobblers, and several whitetails that I either carried, carted, or drug out in my younger days.

Paper company land at this day and time does not remain in the same form for very long. What was once a beautiful mature mix of pine and hardwood forest is now a pine tree plantation. On portions of this landscape I have had the opportunity to see this once gorgeous stand of timber harvested,

replanted in pine plantation manner, and harvested again. With this change of habitat comes a change of which species of wildlife use the land at different times of its growth. The fabulous turkey population that once inhabited that piece of property has basically disappeared with the exception of one or two of them passing through every now and then. There's a few squirrels inhabiting some small slashes of hardwood that voluntarily grew in some of the land's low lying areas that are too low for the pine trees to prosper. Rabbits and whitetails have adapted to the changes of that environment.

The approximately one mile long old access road into the leased property has changed very little in the last quarter century or so. With the exception of a few more potholes developed by some other users who can't seem to do anything without the use of a vehicle of some sort, the old trail remains the same. Without the use of motorized transportation for access it became clear to me how the game traveled on this land. It was those many walks down the old trail before, during, and after daylight that taught me how to be a successful hunter on that property. My trips up and down the old road seemed to open up new and exciting sights and scenes to my outdoor experiences. It was there that I learned to sit and wait for a gobbler that had answered me instead of continuing to go to him. It was on a foggy October morning, on my way to make a squirrel hunt, that one one



the best bucks that I've ever seen stepped out into the old road broadside at fifty yards. He nonchalantly stared at me as I put the crosshairs of my 22 rifle on his chest while wishing that it was another day and time with a larger caliber rifle. It was down this old trail that I witnessed the negative use of poisons to control predator populations. As I was walking down the road scouting for turkeys, I noticed a dead opossum, racoon, buzzard, and a blue heron. I first thought that someone had outlawed the place. I later found out that one of our club members had applied the poison to kill coyotes and bobcats. Bad move and lesson learned. Turned out that other creatures became victims also. I witnessed my first turkey fight on that old road. I even chased two trespassers down the old road one morning at the crack of dawn. I had worked all night long and had made the drive from my job to there in a mad rush. Having walked my way back there for gobbling time, I was in no mood to put up with trespassers who did not belong.

My hundreds of memories and experiences of my lifetime down that old outdoor highway are far more than I can mention here. I have fished in the gravel pit at the end of the road and although it's only ten or twelve years

old it has a good fish population. I haven't hunted that piece of property for several years now. I still have a deer stand on a pipeline off of the beaten path and I do go there once a year to either work on the stand or to retag it for club purposes. Each spring I make myself go there to scout for turkey sign. Hopefully they'll return in good numbers someday but that hasn't happened yet.

Just recently while walking back to my truck down the old road, after attending to my deer stand duties, a strange feeling came upon me. I am now beginning to accept the fact that in the not so long future that I will someday never walk down that old road again. It was a big part of my life and for me just like all of the game that I carried out of there, it's been a path well traveled.




## PROTECT FROM PACKAGE THIEVES






