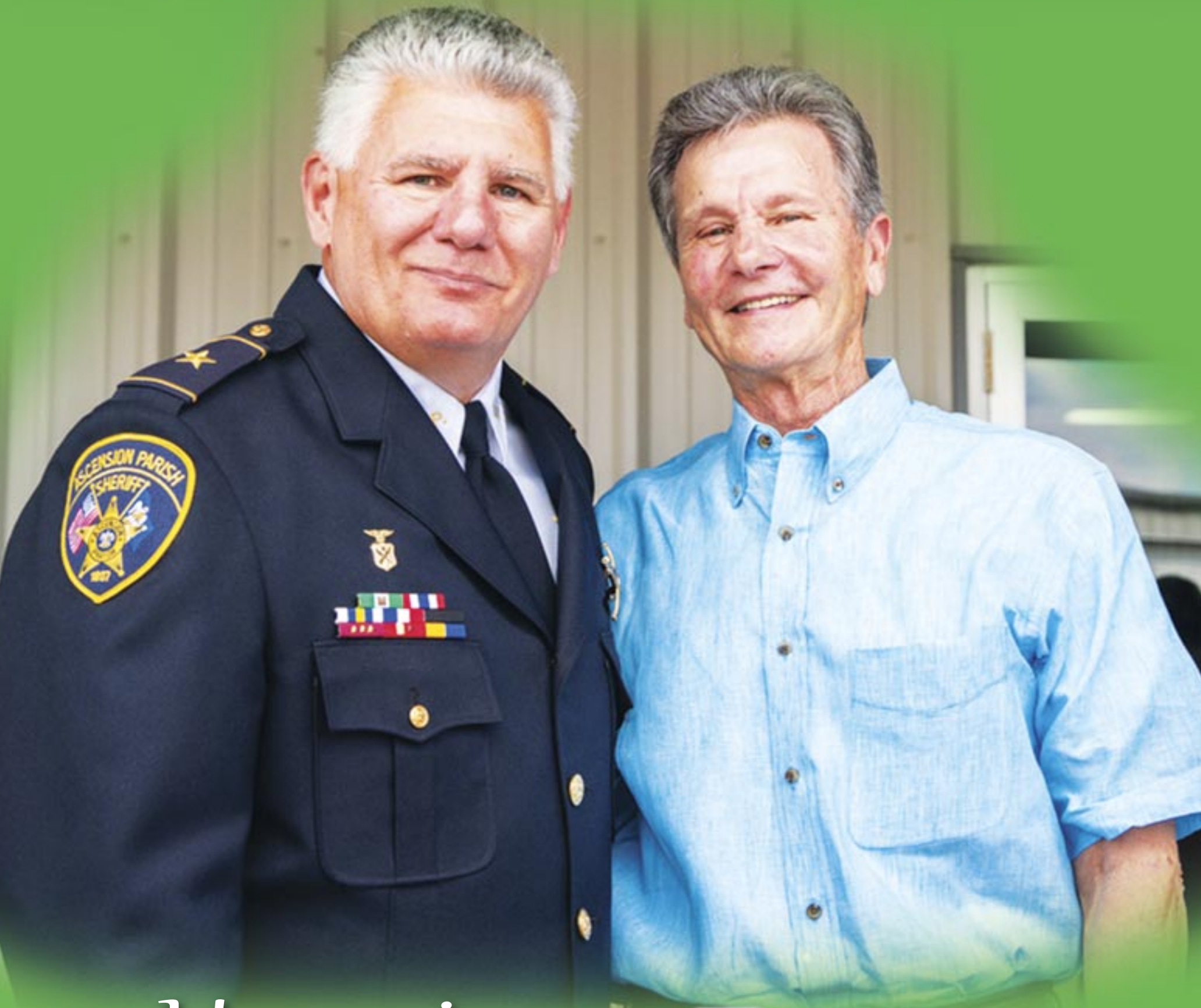

Bama's Feed the Needy Raises \$27,095

Twenty years ago 3 local families were down on their luck and had little for their family for Christmas. Not necessarily for toys but for food. Tommy 'Bama' Aldridge grabbed his black iron pot and cooked a sauce picaunte and sold plates at the Gonzales Country Club and raised \$800 plus dollars. He divided it up and delivered it to these families.

Here Twenty years later he has fed thousands of families. Now it takes a village to restore hope to raise funds through jambalaya sales and donations.

This year the Feed the Needy of Ascension operation sold 675 plates.

The final tally is not in yet but here are the audited numbers for 2024.

Grand total collected 2024: \$29,988.00

- \$11,500.00 disbursed to 5 Ascension Parish Church Food Banks
- \$10,400.00 disbursed to 13 local Ascension Parish schools
- \$1,000.00 disbursed to OTOW
- \$1,500.00 disbursed to CHC Closet
- \$1,000.00 disbursed to EDANB
- \$500.00 disbursed to Courts of St. Anne & Anthony
- \$4,500.00 disbursed to 11 individual families in need

I looked around the KC Hall and there were 30 plus volunteers helping with this noble cause. Bama's small gesture 20 years ago has made us all better

people.

I don't know how long Tommy can keep this up but I can guarantee I'll be there to help. When he started this salvation operation we all were 40lbs lighter and our golf swings were sweet. No matter when it comes to an

end remember how one browned roux and some browned meat that saved a community.

Bama, there are wings waiting for you my friend. However I hope many years pass before you get them.

A Scrooge-Style Wake-Up Call: Five Legal To-Dos Before the Year Ends

Every year when the holidays roll around, I find myself watching at least one version of A Christmas Carol. No matter if it is an old black-and-white version, the Muppet

version, or a newer one, I always get pulled in when Scrooge is shown the parts of his life he has tried to avoid. By the end of the story, he is ready to get his life in order. And I smile every time because I meet so many people who have their own “Scrooge moment.” It might not be as dramatic as the Ghost of Christmas Present yanking them from their bed, but something small happens that makes them stop and think, “I need to take care of this.”

Last December, a good friend of mine, Paul, gave me a call after he had his own moment like that. He was watching a holiday movie with his grandkids when he realized he could not remember who he had named as the beneficiary

on a life insurance policy from his old job. He said he felt like the main character waking up and finally seeing things clearly. He laughed when he said it, but there was truth in it. The end of the year has a way of making us think about our past, our future, and the people we care about.

I told Paul what I tell many families: there are a few simple tasks you can finish before the new year that make a big difference later. These tasks do not take long, but they protect the people you love. Around the holidays, when life slows down for a moment, it can be the perfect time to get them done.

The first thing we talked about was updating beneficiaries. Many people think they are set because they did this once, years ago. But life changes. Families grow. Loved ones pass away. People get divorced or remarried. Paul checked his policy and found he still had his brother listed, even though he wanted everything to go to his daughter now. Fixing it took less time than wrapping a gift.

Next, I asked him to make a clear note of where he kept his digital passwords. You do not have to write the passwords themselves, but you should write down where they are stored and who can get to them. I have seen families struggle to open a parent’s email or online bank account, and it becomes a real burden during an already hard time. Paul had all his passwords saved in one app, but no one knew how to access it. He decided to share the instructions with his daughter so she would

not be left guessing.

Then we talked about checking home documents and bank accounts. Titles and names on accounts can sometimes have small errors that cause big problems later. Paul found that his middle initial was missing on one deed, and an old bank account still had his name spelled wrong. These were simple corrections, but important ones.

Paul also gathered his key documents. He had a will, a power of attorney, and an advance directive, but they were scattered in different places around his house. He put them into one folder and stored it somewhere safe. He then told his daughter where the folder was. That last step may sound small, but it brings a lot of peace to families.


When he finished, Paul told me next time we ran into each other, “You know, this feels like the part in the movie where the character finally wakes up and starts doing the right things.” I told him that taking care of these tasks is not about fear or pressure. It is about love, preparation, and wanting to make life easier for the people who will one day walk behind you. At the very least, doing these things now may save you a visit from three Christmas spirits.

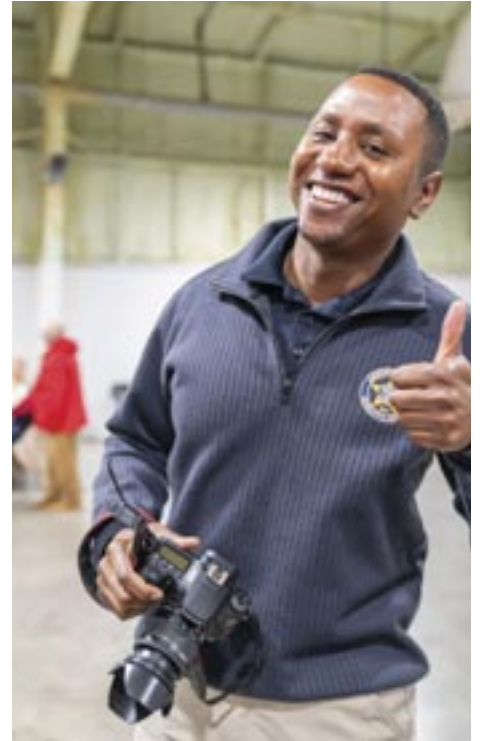

New Year's financial resolutions: Making them stick

As the calendar flips to a new year, millions of Americans pledge to improve their financial lives. But without a concrete plan, those well-intentioned resolutions often fade quickly.

Financial goals consistently top the list of New Year's resolutions. A 2025 CFP Board study shows that financial resolutions are prominent, with saving more money (45%) and reducing debt (32%) ranking among the top

three goals.

Unfortunately, most resolutions don't last. A 2023 Forbes Health poll found that over half of people give up on resolutions by the four-month mark and only 1% make it the full year.

The challenge isn't a lack of desire for change. People may set the same resolution year after year, revealing a disconnect between intentions and action. Or it may be that they try to tackle too many goals at once, or aim higher than is realistic, setting themselves up for disappointment.

Set smart financial goals. Before crafting your action plan, consider which

financial priorities matter most to you. If you need ideas, here are some areas where you may want focus in 2026:

- Regularly review your financial goals and track progress toward meeting them
- Increase your 401(k) contributions or max out your IRA and/or HSA contributions
- Pay down debt strategically and negotiate lower interest payments
- Build an emergency savings fund of six to 12 months
- Save more consistently

Be specific. Vague resolutions like "save more money" rarely succeed. Instead, it can help to make goals specific and measurable. For example, rather than making a resolution to "start an emergency fund," commit to a specific goal, such as, "I will put \$100 a month into an emergency fund."

This shift from general to specific transforms wishful thinking into actionable steps. When goals are attainable, it's easier to track progress and stay motivated.

Find an accountability partner. Don't go it alone. Having someone to check

in with can help you stay on track. This could be a spouse, friend or family member who shares similar goals.

Consider working with a financial advisor who can help you create a realistic plan, monitor your progress and adjust strategies as needed. A professional can provide expertise and accountability, making it easier to stay on track throughout the year.

Start small and build momentum. Rather than overhauling your entire financial life all at once, focus on one or two priority areas. Identify where the largest gap exists between your current situation and where you want to be, then concentrate your energy there.

Breaking larger goals into smaller, manageable actions makes them less overwhelming and more achievable. Each small win builds confidence and momentum for tackling the next challenge.

The new year offers a fresh start and renewed motivation to improve your financial health. With specific goals, a solid action plan and the right support system, this could be the year your financial resolutions finally stick.

East Ascension Sportsman's League

Letter from president -

While sitting in the spare bedroom I call the office, I found myself looking out the window watching the rain fall, thinking back to the first time I heard of the East Ascension Sportsman's League. I was fresh out of high school; it seems like such a long time ago. The first meeting I attended at the Prairieville Volunteer Fire Department came to mind. That is where I learned that EASL has a board of directors and officers who gave their time to run the organization

and work to protect our rights to hunt, fish and conserve our natural resources. That piqued my interest.

A few years later, I was asked if I would run for the board of directors. After explaining to the membership that I wanted to serve on the board to give back to the cause, I found myself elected to the board. It was a great learning experience. EASL hosted fishing tournaments, classes on fishing, National Hunting and Fishing Day events and of course the Annual Kids Fishing Rodeo, among other things. Being on the board gave me the opportunity to learn about the process of writing resolutions to be presented at Louisiana Wildlife Federation convention.

Every year EASL would present a number of resolutions to LWF for support to be submitted to the Louisiana Legislature or Department of Wildlife and Fisheries. Many were passed into law or funded to build boat launches, enhance management areas and protect our resources.

Numerous members received awards for their service over the years and EASL would receive multiple awards, in the organization category, for our service to the cause. There were many good productive years of working together to protect our way of life.

Now, as I see the rain is coming

to an end, I spend my time comparing EASL, then to now. The number of members in the organization and list of activities there were to do back then. Today there are about a quarter of the members and not much for the membership to do as an organization. It pains me to wonder how much longer EASL will last. Wondering if I will be the last president and will be left with no choice but to close the book on EASL's long history. Or will I have the pleasure of passing the torch to a younger generation who will pick it up and fight to protect our rights to hunt, fish and conserve the natural resources against those who would take away our way of life.

As I am about to turn out the light for the night, the words of the John Prine song "Paradise" comes to mind, "And daddy, won't you take me back to Muhlenberg County down by the Green River where paradise lay? Well, I'm sorry my son, but you are too late in asking, Mr. Peabody's coal train has hauled it away." HOLIDAY THEFT PREVENTION



PROTECT FROM PACKAGE THIEVES

Monitor when your packages are expected to arrive and don't leave them on your porch or in your mailbox. Sign up for delivery notifications. If possible, ship your packages to your workplace or have a neighbor who is home during the day collect your packages for safekeeping.

Keep the interior of your vehicle clean. Never leave gifts or shopping bags in plain sight. Lock valuables in your trunk or remove them before exiting your vehicle. Remove all gifts and items of value from the vehicle when leaving it overnight.





PROTECT FROM HOME BURGLARS

A Christmas tree in your front window is an invitation to a burglar. Set up your tree in a location not easily seen by passersby or cover your windows with blinds/curtains overnight and while you are away from your home. Another option is to wait to put presents under the tree until it's time to unwrap them.

PROTECT FROM HOME BURGLARS

After presents are opened, break down all boxes and place in the garbage or recycling. If packaging is too big to fit in the receptacles, drop it off at the dump. Do not leave packaging materials outside your home for garbage collection. Leaving a box for a brand new TV, or other gifts, outside your home alerts thieves to high-dollar items inside and puts you at an increased risk of a home burglary.

Kid 1- You're running late this year, Uncle Bill. I was almost getting visions of Sugar Bowls dancing in my head.

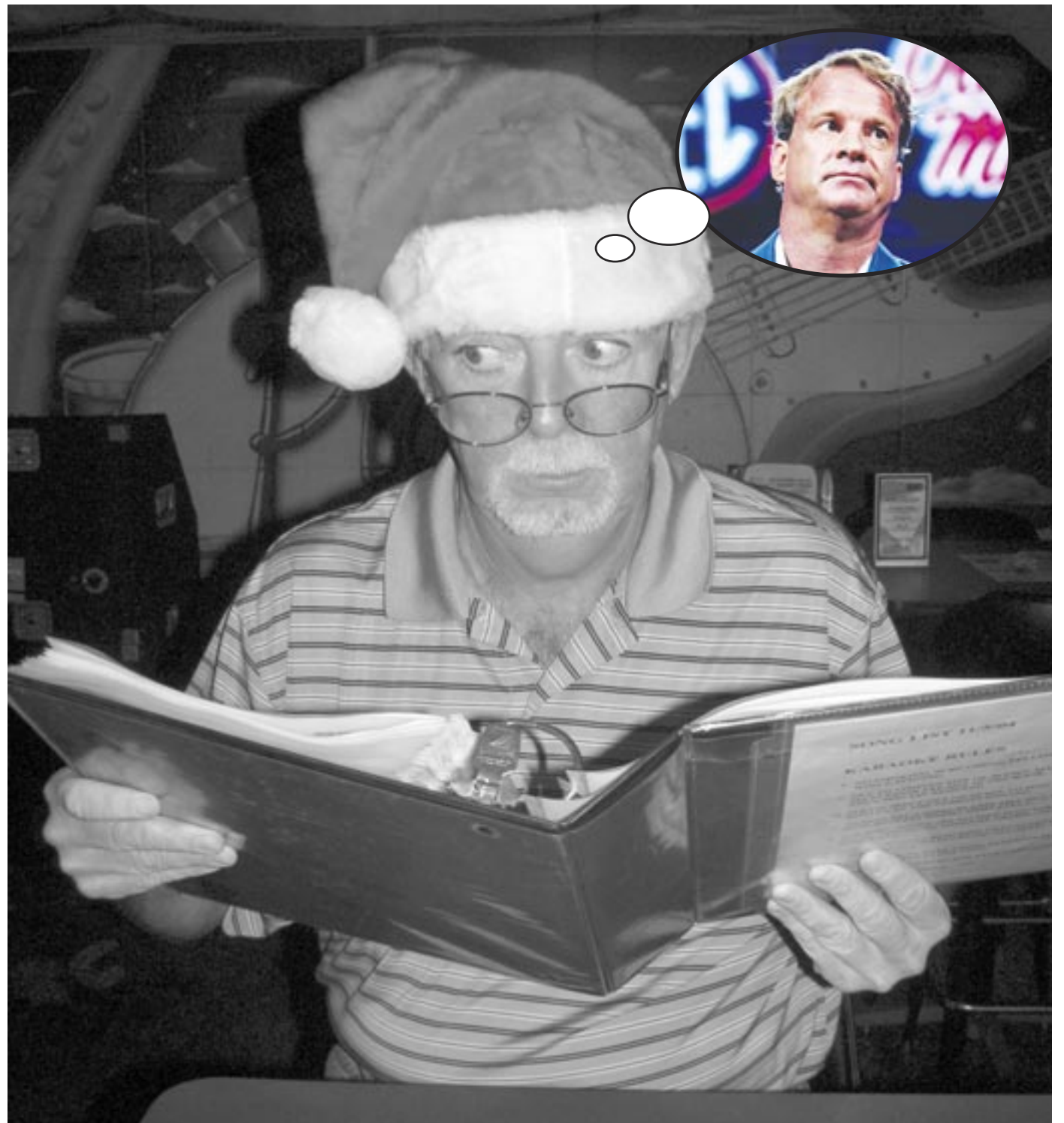
Bill- Yeah, I had to stop off at that new medical marijuana dispensary in downtown Prairieville so I could get a few visions of my own.

Access

Shortly after that time a couple of friends of ours brought the piece of land. They soon acquired a way in and out and by all means that acreage was all you could ask for when it comes to turkey and deer hunting. The place had a nice fishing pond located on it as well. Dad regretted the decision of not buying the land for the remainder of his life.

For many years now I have had a very easy access point to a portion of one of my hunting clubs property that

I have a personnel stand on.

I have hunted that little section of woods for thirty years now. For many of those years I had entered the spot through our club's property. I could still do that although my old trail and the surrounding forest is now privately owned land and the only other way to get there through our club's property is a pretty big hassle for me to do so. For the past fifteen years or so I've been fortunate enough to park and enter the spot from some private property that borders it. The first person that gave me permission to do so was a security guard of a nearby casino who was renting the homestead of the bordering land. After he moved on an

elderly lady who was raising her two grandkids took up the residency. We became good friends and she always welcomed me to enter and park at the location. When this lovely lady moved on, an employee who managed a nearby convenience store that was owned by the actual owner of the property gave me permission to carry on with my mission. During that stretch of different renter years I would always bring whoever was responsible for allowing me to park there a backstrap at the end of each hunting season to show my appreciation for that gift.

This past summer as I went to the area to get prepared for the upcoming



season I noticed that a couple of men were at the establishment working on the properties holdings. After seeing the new too me folks I began to have doubts of what could come about with my situation. When I returned to my vehicle, a man approached me and told me that the owner didn't want anyone hunting there this year. The hip guy was an employee of the owner who was working on the establishment and living there as well.

I explained to him my situation and how difficult it would become for me to do otherwise. At the end of our conversation I asked for the owner's telephone number and he politely quoted it to me.

As I headed back home I became determined to get in touch with the owner and ask permission to park and enter from his land. After several calls and text messages I had not yet got in touch with the older gentleman. I figured that someone of my age probably wasn't going to answer a call from an unknown number for fear of scams etc. After several days of no luck on the calls and by asking others of his whereabouts I found out the name of the business he worked for. I'd made up my mind to drive to that location and talk to him if I had too. I just had to explain to him that I only use the spot two or three times a year. He needed to know who I was, what I was really asking for and how I would respect his property at all times if permission was granted. I had decided to offer a payment for the privilege of doing so if necessary.

Believe it or not, one day

before I planned to make tracks to his job site my phone rang and I enjoyed a conversation with one of the nicest people I have ever talked to. I explained my need to him and promised that I had never and would never take advantage of the privilege if permission was granted. I also revealed to him that I would never take any other person from our club there unless I needed their help to retrieve an animal.

I pledged to him that I would always respect his property in every way. We talked for a while about several other things and when it was all said and done he told me to send a picture of my vehicles and their plates to him. He then called the attendants and told them to let me access the lease from his property.

There's no need to have hunting property if you have no way in and out of it. Anything that makes it easier to do is a blessing for sure. In these days and times I must say that allowing someone on your property can be a risky situation for the land owner to be a part of. If you are ever given permission to access property from a piece of land owned by someone else be sure to always respect that privilege to the fullest.

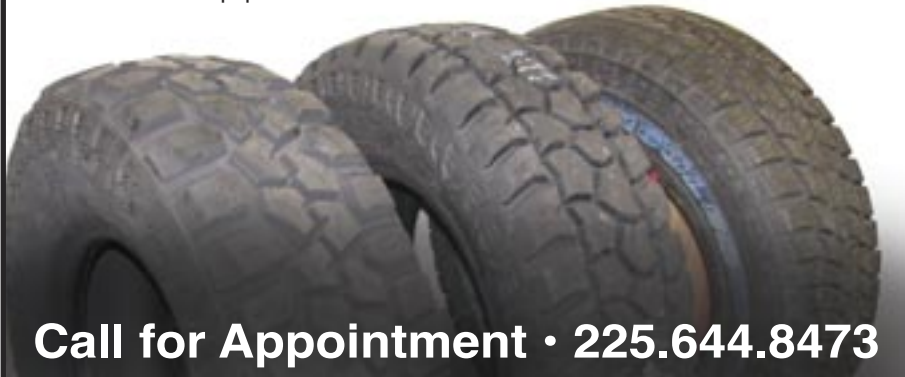

Purple Raisins.	½ oz

Instructions:

First remove the white film from the brie by scraping it with the back of a butter knife. Score the brie wheel with a chef knife four times diagonally. Preheat oven to 500 degrees. 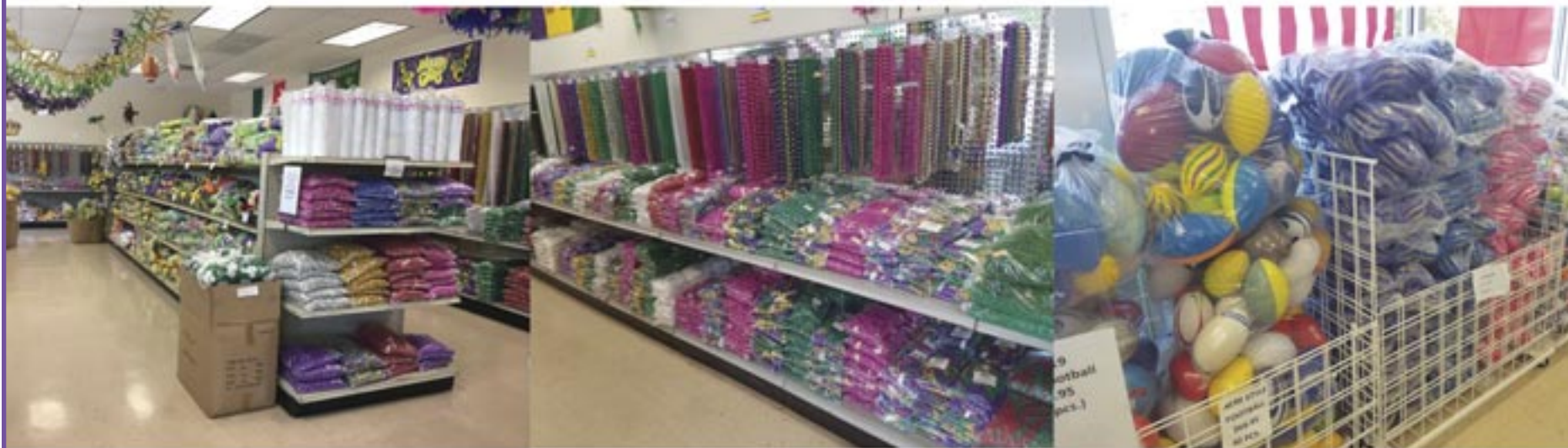
