A message from our president



Is North Dakota For Sale?

As we have all heard about the buying of North Dakota Land by Bill Gates from Campbell Farms (a potato operation), we first think, well, that's in the NE part of N.D. and has little to do with the livestock industry.



Menoken, ND – Recently, I-BAND was instrumental in urging the Farm Service Agency (FSA), State and National offices, to re-evaluate the Livestock Indemnity Program (LIP) payment rate and normal mortality rate for beef cattle that are under 250 lbs. Prior to 2020, there was one weight class for non-adult beef cattle under 400lbs that provided a fair indemnity for younger calves lost to a natural disaster. Today, the Livestock Indemnity Program (LIP) has two weight classes for calves under 400 lbs., the lowest being under 250 lbs.

The April winter storms that rolled through North Dakota one after another left our cattlemen and cattlewomen with extreme losses, most occurring in the under 250 lbs. weight class. Each calf they were unable to raise to weaning will reduce their annual income by \$1000-\$1200. Many ranchers have already paid the expenses to raise those lost calves until weaning. The financial outlook caused by these storms were catastrophic.

The payment rate according to LIP policy is set at 75% of the fair market value. Previously, the rate for this program for calves under 250 lbs. was \$175. That puts the estimated average market price at \$233. As of July 18, 2022, the payments rates for beef have been updated to use the same price as the 251-to 399 lb livestock. The rate is now set at \$474.38 per head for the cattle weighing less than 250 lbs.

LIP payments previously paid for the livestock types of beef, beefalo, buffalo/bison, and dairy under 250 pounds and 250 to 399 pounds will be recalculated to pay the updated amount once the updated amounts are loaded into the LIP software. If no update to the application was made, no further action is required.

North Dakota approves Bill Gates' major farmland purchase

North Dakota's state attorney general's office approved Bill Gates' recent purchase of 2,100 acres of farmland. The attorney general's office scrutinized the initial investment based on the state's barring of corporations and limited liability companies from purchasing farmland.

In the state's original letter to Gates, North Dakota Attorney General Drew Wrigley wrote, "Our office needs to confirm how your company uses this land and whether it meets any of the statutory exceptions, such as the business purposes exception."

U.S. land prices have been soaring, but an aging demographic of farmers may spell opportunity for young and would-be farmers. However, a select few have been able to meet new prices without hesitation. Among these select few is Bill Gates' Red River Trust, which now owns nearly 270,000 acres of land across the country. Almost 90 percent of this land is farmland, with smaller transitional and recreational area holdings. In total, the trust owns \$13.5 million in farm acres.



Although more than 97 percent of American farms are owned by families, the remaining is owned by corporations. Gates is not only the **fourth richest man on the planet**; he is now the largest private owner of American farmland, according to **The Land Report**, leaping ahead of Ted Turner by about 70,000 acres. The farmland that Gates owns is located in 19 states. However, the land held only amasses 1 percent of the total acres of farmland in the United States. Gates is also number 49 on a list of individuals, families, and businesses who own farmland in the states.

What does a technology pioneer want with agriculture? The future is in agri-tech, and Gates believes that he is too. The billionaire launched Gates Ag One through the Bill and Melinda Gates Foundation. The nonprofit organization will help to provide access to technologies that will maximize yields and fight climate change in developing countries.

However, since the 2021 report showing how large of a landowner Gates is, many farmers have spoken up in blog posts and on social media uneasy — and in some cases, upset — about Gates' growing role in the industry. *The Land Report's* <u>research</u> insinuates the land is held directly by Gates and also by third party entities, such as Cascade Investments and Red River Trust, that is run by Gates' investors.

Gates responded to an Ask Me Anything session on Reddit by saying, "The agriculture sector is important. With more productive seeds, we can avoid deforestation and help Africa deal with the climate difficulty they already face. It is unclear how cheap biofuels can be, but if they are cheap, it can solve aviation and truck emissions."

NORTH DAKOTA DEPARTMENT OF AGRICULTURE RECEIVES FEDERAL GRANT TO IMPROVE ACCESS TO LOCAL FOODS IN SCHOOLS

"The enhanced Farm to School program will increase the amount of locally produced foods served through child nutrition programs," Agriculture Commissioner Doug Goehring said. "Serving North Dakota food products grown by our farmers and ranchers and processed by local businesses will also help children learn how their food is raised and produced."

As part of the grant, NDDA will conduct comprehensive Farm to School programming, including local procurement and agricultural education efforts.

Animal care will follow the Five Freedoms, and there will be a consistent approach to antibiotic use and reporting across herds in line with Walmart's Position on Antibiotics in Animals, which asks suppliers to adopt and implement American Veterinary Medical Association Judicious Use Principles of Antimicrobials. All of these components will help Sustainable Beef LLC to improve and refine the beef supply chain to provide quality beef for our customers.

"We set out on a journey two years ago to create a new beef processing plant to add some capacity to the industry and provide an opportunity for producers to integrate their business of raising quality cattle with the beef processing portion of the industry and do it in a sustainable manner, said David Briggs, CEO of Sustainable Beef LLC. "During this journey we found that Sustainable Beef and Walmart aligned on continuing to improve how we care for our animals and crops and provide consumers the positive experience of enjoying quality beef."
