THIS AFFIDAVIT MUST BE COMPLETED BY A PERSON WHO IS <u>NOT AN HEIR</u> OF THE DECEASED, WHO IS NOT INTERESTED IN THE DECEASED'S PROPERTY, AND WHO WILL NOT GAIN FINANCIALLY FROM THE DECEASED'S ESTATE. THE AFFIDAVIT MUST BE SIGNED BY THE PERSON COMPLETING THE FORM, AND THE SIGNATURE NOTARIZED BY A NOTARY PUBLIC. THE AFFIDAVIT MUST THEN BE SENT TO SYDRI.

PLEASE ATTACH TO THE AFFIDAVIT OF HEIRSHIP:

- 1) A COPY OF THE DECEASED'S CERTIFIED DEATH CERTIFICATE.
- 2) IF THE DECEASED LEFT A WILL, A COPY OF THE DECEASED'S WILL.
- 3) THE COMPLETE ADDRESS FOR ALL HEIRS.
