THE AFFIDAVIT MUST BE SIGNED BY THE PERSON COMPLETING THE FORM, AND THE SIGNATURE NOTARIZED BY A NOTARY PUBLIC. THE AFFIDAVIT MUST THEN BE SENT TO SYDRI.

- 1) A COPY OF THE DECEASED'S CERTIFIED DEATH CERTIFICATE.
- 2) IF THE DECEASED LEFT A WILL, A COPY OF THE DECEASED'S WILL.
- 3) THE COMPLETE ADDRESS FOR ALL HEIRS.
