What Is A Data Privacy Notice & Why Is It Important

We know your personal information is important to you and it is important to John Morris Landscapes too. This Privacy Notice tells you what we use your personal information for and explains your rights around how we use it. Please read this Privacy Notice to understand how and why we use your personal information. It is important to point out that we may amend this Data Privacy Notice from time to time. If you give us personal information about someone else, please make sure you have their permission and make them aware of this Privacy Notice.

The Information We Collect About You

John Morris Landscapes is a Data Controller as defined under Data Protection Law. John Morris Landscapes will only collect personal data from you that is relevant to the service(s) that you are availing of at that time. We will take great care with the information provided, and will take necessary steps to keep it secure and to ensure it is only used for legitimate and specified purposes. We will not keep any information we hold about you for any longer than is necessary. This processing of information applies to both our online and offline work practices.

If you are a **Personal John Morris Landscapes Client:** We receive your personal data directly from you and we use your personal information only to provide you with the service that you have engaged us to provide you with.

If you are a **Corporate John Morris Landscapes Client:** We receive your personal data directly from you, the business and we use your personal information only to provide you, the business with the service that you have engaged us to provide you with.

The data we collect about Clients is actually very limited. We generally only need to have your contact details (such as names, addresses, telephone numbers and email addresses) and we will also require invoicing details to enable us to ensure that our relationship runs smoothly.

If you are a **Website User:** We collect a limited amount of data from our Website Users which we use to help us to improve your experience when using our website and to help us manage the services we provide. This includes information such as how you use our website, the frequency with which you access our website, and the times that our website is most popular. We also record any queries submitted via our website. See our website Privacy Statement for further information

Who We Share Your Personal Data With:

We may pass your personal information to third parties and to contractors only where necessary, and to regulatory authorities that need the information by law. Your data will not be passed on to third parties for the purposes of direct marketing.

Transfer of Data

Your personal information is processed and stored within the EU. John Morris Landscapes will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Notice and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.

How Long Do We Keep Personal Data For

We keep and use your personal information for as long as you are a customer of John Morris Landscapes. We only retain your personal data for as long as is necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting or reporting requirements.

Your Rights

• Right to Correct and Update

You can ask us to correct and update personal information we hold about you.

• Right to Delete and Be Forgotten

You can have your personal information deleted if it is incorrect or has been processed unfairly or unlawfully. However, if we have provided a regulated product or service to you, we must keep your personal information for a minimum period by law.

• Right to Portability

You can ask for a copy of all personal information held by us in an automated format, that you gave us, including through your interactions with us. You can receive this in a machine

readable format. You may also request that we send this personal information in a machine readable format to another company. The format will depend on our ability to provide this in a secure way that protects your personal information.

Right to Access

You have the right to know what personal information we hold about you and to receive a copy of your personal information.
