One of the exciting local and region impacting initiatives I am volunteering on, at present, is the East Side Buffalo community's overwhelming opposition to the U.S. State of New York's \$1.5Billion Route 33 Kensington Expressway Project. After my research established that studies conducted all around the world have proven such roadway's high toxicity to human life, and to property values, I was all-in for the long haul. In fact, my interest in assisting and helping to empower my city's predominantly Black and African American East Side community was so great, I took off my final semester of undergraduate education, to see what I might accomplish alongside others thusly inclined. We have managed to gain a New York State Supreme Court Order halting start of the exprewway project, and the state's Department of Transportation must complete a comprehensive Environmental Impact Statement, before the work can commence. I am very pleased, and proud, of my network's accomplishment, and stories concerning our efforts abound in our region's premier daily newspaper: The Buffalo News.

#### Moving Forward, Looking Ahead

Please know that I am also an entrepreneur who owns 100% of The Heavensgate Company, which has an environmental consultant subsidiary called Covington Associates Consulting. I also founded a nonprofit to further my environmentalism advocacy focus, called East Side Collaborative Partnership. At ESCP, I am currently pursuing a grant opportunity that will enable our group to conduct an East Side Buffalo Community Opinion and Public Health Survey, relative to the historic negative impacts of the Kensington Expressway. I am also trying to expand The Heavensgate Company into the communications conglomerate I believe it has the enormous potential, to become.
