Purpose Of The Compulsory Workshop

- To provide participants with a clear understanding of the 2021-2029 USA Gymnastics Women's Development Compulsory Program: concepts, compulsory exercises, the interpretation of the text, and technical execution of the skills.
- To enhance the knowledge of the teachers, coaches, and judges, enabling them to effectively and professionally serve in the development of the young gymnasts engaged in the USA Gymnastics Women's Development Program.
- To provide an opportunity for coaches to earn W311 University credit.
- To provide an opportunity for judges to earn Continuing Professional Education clinic credits.

Method Of Instruction

- "Active Participation": "Walk through" parts of the routines for all levels of Balance Beam and Floor Exercise. In general, the group participation on the floor will be limited in time in order to cover all the material. Registrants will be expected to define if they plan to actively participate in the floor and beam sections, or if they plan to observe from a seated area. This will help the Master Presenters in the planning process.
- "Lecture Demonstration": For all levels of Vaulting, Uneven Bars, Flexibility and Conditioning

Florida Compulsory Workshop Information

Florida will be hosting 2 compulsory workshops in June. Clubs that attended a Florida State Meet this year and judges that are USA Gymnastics & NAWGJ Florida members since 2019-2020 will be able to register for one clinic for free. Clubs may register 2 coaches for free - each club will receive 2 credentials for the clinic which will allow 2 coaches from your club to attend each day - you can send different staff on each day if you want - there will be a fee due if you want to purchase a 3rd credential.

We need to limit the number of attendees as we may still be dealing with some covid restrictions so both clinics will fill on a first come basis.

Tentative schedule will be sent out next week. The updated registration form is posted in the body of the email this newsletter came through. Please register for the clinic of your choice soon for these spots will fill up fast!
