Q & A From the Brush Up Clinics

- Q: Video Review can a split leap be reviewed for degree of split?
- A: No, you cannot review a split or cast judgement call by the judges. If the judge said that they did not see a leap, then you could review it.

Here is the specific wording in R&P (page 109, H.5.a: a.):

At all sanctioned competitions, a coach can request video review by the Meet Referee and the highest rated unaffiliated judge (if video is available) in the event that the inquiry involves possibility that the judges missed an element that would affect the Start Value. The video review process may NOT be used to appeal a judgement of degree assessment, i.e. degree of casts, handstands, incomplete turns, direct connection of elements, or leg separation in leaps as well as other like skills.

- Q: Are single rooms required to be provided by the Meet Director in 2021?
- A: As per the 2020-2021 Florida USA Gymnastics Travel Guidelines:

HOTELS/LODGING: Hotel rooms will be provided to judges that require overnight lodging prior to or during the competition. The Meet director must specify if accommodations will be double occupancy or single rooms. If a Meet Director plans to provide double occupancy rooms, a judge may request a single room and pay for 50% of the cost of the room per night. The hotel cost will be deducted from the judges check. The Meet Director will inform the judge of the cost of the room prior to the competition.

- Q: Are face shields allowed to be worn?
- A: Unless specifically allowed by the Meet Director, a face shield may be worn IN ADDITION to a mask. Meet Directors need to inform judges what type of face covering is required.
- Q: I'm getting confused which virtual clinics receive credit for CPE and which ones can be used for National/Brevet testing eligibility under the "Educational Events" category?
- A: ALL sanctioned and USAG approved virtual clinics can receive CPE clinic credit. Only those sanctioned clinics that are at a Regional level or above can be used for National/Brevet eligibility. Examples include: Region 7 clinic from June 2020 and National Congress in August 2020. The virtual clinics hosted by Oregon and Georgia were at the State level, therefore they're eligible for CPE, but not National/Brevet testing.
- Q: Regarding National/Brevet testing eligibility and the adjustments to the requirements does the volunteer portion require 1 or 2 different events?
- A: It is still 2, though the total required hours have been reduced from 12 hours to 6. See below for the last 2 opportunities offered in FL before the eligibility window closes (deadline to complete the eligibility form is 12/31/21).
- Q: Will there be any State Clinics next summer (2021)?
- A: Yes, USAG FL is planning to host compulsory clinics on 2 different dates in June 2021 at 3 separate locations. Serena Albauer is the State Clinic Coordinator and more information will be coming out after USA Gymnastics finalizes their events. The State Clinics can earn CPE clinic credit for judges and will be free to all active FL NAWGJ judges. Space will be limited at each location.

IRS Rate For 2021 – It's Going Down

The Internal Revenue Service (IRS) has issued its 2021 standard mileage rates. Beginning on January 1, 2021, the standard mileage rate for the use of a car, van, pickup or panel truck will be: **56 cents per mile** for business miles driven (down from 57.5 cents in 2020)
