FL NAWGJ – What You Need To Know



Effective January 1, 2022 the standard business IRS mileage rate goes up to 58.5 cents per mile.

USA Gymnastics Membership sent the below information out recently. I am sure you've noticed that Region 8 Congress is not listed. Well, that's because National Congress will be conducted in Region 8 this year (location to be announced very soon). When National Congress is held in a Region, that Region doesn't have a Regional Congress in that year.

You now have the dates that testing will be held for the National/Brevet. The exact locations and registration for all congresses will be released in early 2022. Judges may test at any Regional or National Congress.

- National Congress: August 19-21, 2022 (*held in conjunction with U.S. Gymnastics Championships*) **To be held in Region 8**
- Region 1 Congress: August 26-28, 2022
- Region 2 Congress: August 13-14, 2022
- Region 3 Congress: June 10-12, 2022
- Region 4 Congress: June 17-19, 2022
- Region 5 Congress: July 15-17, 2022
- Region 6 Congress: August 5-7, 2022
- Region 7 Congress: June 24-26, 2022

CPE 2022 – What You Need To Know



It may seem early, but it's never too early to think and plan for upcoming CPE. As of January 1, 2022, I will be accepting completed CPE forms for the 2021-2022 judging season. Due to Covid and a variety of other things, the requirements were modified for the past 2 years, but effective immediately, the requirements are going BACK to what they were. Here's what you need to know:

- Completed forms are being accepted now and the deadline is May 31, 2022.
- Forms can be found on the USAG website and our nawgjflorida.org site.
- Fill out, scan and send a PDF – please no phone pics or jpegs. Send to susan_78726@hotmail.com
- Activities dated June 1, 2021 and forward may be used for the upcoming year.
- YEAR: August 1, 2021 – July 31, 2022 HIGHEST RATING HELD AS OF AUGUST 1: _____
(whatever your rating was on August 1, 2021, then put it here ←↑ and that determines what requirements you need to meet – below)
- Requirements:

- SGB Member or SJD/RJD or National NAWGJ officer can receive 2 Volunteer (misc) hours.
- Practice Judging (misc) must have pre-approval from the SAC or SJD. Currently, only our FL NAWGJ Judges' Cup has this approval.
- In-Gym (misc) must be interactive with coaches/gymnasts. You cannot sit in the stands watching and/or judging to receive credit. You need to get permission from the coach/owner to be on the floor and one of them need to sign your CPE form when you're done.
- If you did not submit CPE this year (and obviously did not judge), then you do not need to make up those hours. You just need to submit CPE prior to your return to judging.
- Though CPE is due May 31, 2022, late submissions are accepted throughout the year – you just cannot be assigned or judge until you are CPE compliant.
- Please contact your Mentor if you need assistance with a CPE plan. Please contact me if you do not have a Mentor and need assistance with a CPE plan.
- Currently, FL is not hosting any Regional or higher competitions in 2022, but we are hosting Level 9/10 Regionals (Bradenton) and Xcel Regionals (Ft Lauderdale) in 2023. Plan accordingly for these are wonderful opportunities to receive volunteer hours, meet National/Brevet eligibility and we always need your help!
