FL NAWGJ – What You Need To Know



Q: Level 2 Vault – the deduction reads "failure to place hands in the prescribed landing zone – both hands land beyond the tape line-0.50". Do the hands have to be completely over the line or partially over the line (like on floor)?

A: The 0.50 deduction is taken when both hands are COMPLETELY over the line. Partially crossing over the line (fingertips) is OK and no deduction is taken. Answered by Linda Thorberg, Region 4 RTC

Q: Xcel Silver Vault – is there a "contacting the mat stack with the hands after vertical, up to 1.00 deduction for Silver like the Level 3 Vault?

A: Unfortunately, the Level 3 Vault deduction is NOT used in Silver, however in the future I believe the intention is to have as much of the same general deductions between the 2 programs to make it less confusing for all involved.

Q: Xcel Bronze Beam – can a Bronze athlete use the "mountain climber" to partial handstand like in the new Level 2 beam routine?

A: Yes, this is an acceptable entrance. Answered by Pam Kitchen, Region 8 RXCC

Q: Xcel Floor – how many back handsprings can be done and still receive value part credit?

A: Acro elements with hand support receive value part (VP) no matter how many times they are performed, provided they are in a different connection. For example: a gymnast could do RO, BHS and RO BHS, BHS and then a single BHS and that would be fine. If they did RO, BHS again, that would not work since it's a repeated connection.

U112: Tough Coaching or Emotional Abuse: Knowing when the line has been crossed. Though this course is NOT required for judges, it IS required if you are also a:

- Competitive Coach
- Recreational Coach
- Organizational Owner / Managing Director

This course must be completed by January 12, 2022. To verify the completion of this course, go to your User Profile page and click on "Course History". For assistance with the course - login, navigation, technical assistance, test reset, or other needs - please email the USA Gymnastics Education Department at <u>education@usagym.org</u>. If you do not complete this course by the stated deadline, then your membership will go into "pending" and you will NOT be allowed on the floor of a sanctioned event, therefore you would need to be replaced on all judging contracts until this course is completed.
