



## Maplewood Safe Bike Skills Course

### **Permission Slip/Photo Release/WAIVER of Liability, Assumption of Risk & Indemnity**

Meadowlands Transportation Brokerage Corporation, doing business as EZ Ride, along with the Maplewood Police Department (collectively, Partner Organizations) are hosting a Bike Safe Skills Course from 11:00-12:30 pm and from 12-1:30 pm on June 11, 2022 at the Maplecrest Park Tennis Courts at 1618 Springfield Avenue in Maplewood, NJ. Permission is required for your child to attend and participate in this fun and educational event. Each child must provide their own bicycle in good working order, and their own helmet, which they will be required to wear at all times during the event. If a child does not have a helmet, please indicate below and EZ Ride or one of the Partner Organizations will provide a helmet. Parents/legal guardians are responsible for transportation of the children to/from the event.

Your child may be photographed during this event and the photographs may be used for positive press coverage by any of the event's Partner Organizations, including EZ Ride and Safe Routes to School.

No child will be permitted to participate without this executed permission slip and WAIVER/ liability release being on file prior to the event.

As the minor's parent and/or legal guardian, you must understand the nature of bicycling, the minor's experience and capabilities related to bicycling and truly believe the minor to be qualified, in good health and in proper physical condition to participate in such activity.

Additionally, while EZ Ride and the Partner Organizations will take all reasonable precautions, it is not possible to completely prevent against the presence of COVID-19, or its spread during the event. If you choose to allow your child to participate at this event, you may be exposing your child or your family to the risk of COVID-19.

**ASSUMPTION OF RISK:** I have read and understood the above, including the warning concerning COVID-19. I hereby choose to accept the risk of any injury or sickness, including contracting COVID-19, in order to utilize EZ Ride's services and allow my child to participate at this event. These services are of such value to me that I accept the risk of injury and being exposed to contracting and spreading COVID-19 in order to utilize EZ Ride's services.

**WAIVER AND RELEASE OF LIABILITY:** In consideration of my child being permitted to participate in the Safe Bike Skills course, I hereby forever release from liability, and waive my right to bring suit or make ANY claims against, Meadowlands Transportation Brokerage Corporation, doing business as EZ Ride, and all Partner Organizations, their officers, directors, managers, trustees, agents, employees, or other representatives, in connection with any injury, exposure, infection, and/or spread of COVID-19 related to utilizing EZ Ride's services at this event. I understand that this waiver and release means that I release EZ Ride and the Partner Organizations, from, and give up my right to bring any claims for, any and all liability, loss, cost, or expense, including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.
