5. Though there is no technical definition of a "high capacity" magazine (firearm ammunition feeding device), gun control proponents designate some magazines as "high capacity" based on an arbitrarily chosen number of rounds a magazine can hold.

7. The General Accounting Office, which is a watchdog within the U.S. Justice Department, reported in 2016 that the federal government was illegally retaining the names of thousands of law-abiding gun buyers. 9. Legislation in Congress would allow a person who can legally carry a concealed firearm in his or her home state to also have the right to carry in other states. They label these proposals as a crackdown on "gun trafficking," but this legislation will trap innocent gun owners and do nothing to prevent illegal gun trafficking by the drug cartels.

15. A very popular device utilized by gun owners and hunters is a suppresser, which muffles the sound of a gunshot. However, suppressors are highly regulated by the unconstitutional National Firearms Act, which requires intensive background checks, waiting periods, tax stamps and registration. Furthermore, the ATF has called such regulations archaic, questioning why suppressors are regulated by the federal government in the first place.

16. After recent mass shootings, there has been a major effort to amend federal laws to allow the issuance of Gun Confiscation Orders (GCOs). Sugar-coated as "red-flag laws" or "extreme violence protection orders," Gun Confiscation Orders would allow police or an aggrieved "ex" to convene a secret star-chamber hearing from which the gun owner would be excluded. In anti-gur states where GCO's have already been enacted, judges routinely "ask few questions" before issuing the order to order to ransack the gun owner's home searching for firearms.
