GENERAL WASHINGTON'S VISIT BY DR. JAMES T. HERRON

It was a typical Western Pennsylvania September afternoon in 1784 when George Washington and his friend Dr. Craik rode up to John Canon's log house in Canon's Burg.

GENERAL WASHINGTON HAD RESIGNED HIS COMMAND OF THE COLONIAL ARMIES THE PREVIOUS YEAR AND RETURNED TO MT. VERNON. HE WAS NOW ON A TOUR TO INSPECT HIS LAND HOLDINGS IN THIS SECTION.

IN PARTICULAR, HE WAS CONCERNED ABOUT A BLOCK OF 2,800 ACRES IN MT. PLEASANT TOWNSHIP WHICH HE HAD BEEN GRANTED UNDER A VIRGINIA MILITARY PATENT. THE LAND WAS OCCUPIED BY AT LEAST 13 INDIVIDUAL SETTLERS, WHO HAD ERECTED CABINS AND CLEARED ACREAGE, BUT DENIED WASHINGTON'S OWNERSHIP AND REFUSED TO BUY, RENT OR MOVE OFF THE LAND.

IN WASHINGTON'S JOURNAL OF HIS TOUR HE WRITES, UNDER THE DATE OF SEPT. 18, 1784: "SET OUT WITH DR. CRAIK FOR MY LAND ON MILLER'S RUN (A BRANCH OF SHURTEES CREEK)....LODGED AT A COLO. CANNON'S ON THE WATERS OF SHURTEES CREEK - A KIND HOSPITABLE MAN, AND SENSIBLE."

Two years later, Washington appointed Canon his agent for the Millers Run lands with power of attorney to rent or sell said lands.

THERE ARE SEVERAL INTERESTING STORIES THAT CAN BE READ BETWEEN THE LINES OF WASHINGTON'S ENTRIES FOR THE THREE DAYS HE SPENT AS COL. CANON'S GUEST, AND OF THE ENSUING LEGAL SUITS TO EVICT THE TENANTS ON THE MILLERS RUN LAND. NONE OF THESE INCLUDE THE FABRICATED TALE OF WASHINGTON'S BEING FINED BY SQUIRE REED FOR SWEARING. THIS PIECE OF LOCAL FOLKLORE HAS NO RECORDED HAS NO RECORDED FACTUAL BASIS AND WAS DENIED AS HAVEING EVER OCCURED BY THE SON OF SQUIRE REED.
