

**VOLUNTEER INFORMATION
&
RELEASE AND WAIVER OF LIABILITY**

VOLUNTEER NAME (print): _____ (“Volunteer”)

In return for being allowed to participate with Hadassah’s Hope, Volunteer with full knowledge of his/her rights does hereby freely, voluntarily, and without duress execute this Waiver and Release under the following terms:

ACTIVITIES: In connection with Hadassah’s Hope, Volunteer may have the opportunity to participate in a number of service activities, including but not limited to preparing and delivering food, visiting adult entertainment establishment (AEE), interacting with dancers or other employees of AEE, coming into inadvertent and incidental contact with patrons of AEE, attending service events away from the AEE, preparing care packages, attending training meetings and/or related activities incidental to Volunteer’s participation, as well as local transportation to and from volunteer sites (collectively “Volunteer Activities”).

WAIVER AND RELEASE: Volunteer does hereby release, waive, discharge, and relinquish Hadassah’s Hope, its officers, employees, successors, assigns, legal representatives, agents, or the organizers, sponsors and supervisors of events, from any and all liability, claims, causes of action, loss, damage, demands, in law or in equity, of whatever kind or nature, arising out of or related to Volunteer’s participation in the Volunteer Activities with Hadassah’s Hope.

MEDICAL TREATMENT: Volunteer does hereby release and forever discharge the Released Parties from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with Volunteer’s participation in the Volunteer Activities or with the decision by any representative or agent of Hadassah’s Hope to exercise the power to consent to medical or dental treatment.

ASSUMPTION OF THE RISK: Volunteer acknowledges that Volunteer’s participation in Volunteer Activities and events may involve risk of injury, illness, death, property damage, and other economic or noneconomic losses, which may result from my own actions, inactions, or negligence; from the actions, inactions, or negligence of others; from the conditions of the facility; or from the equipment or areas where the event is being conducted. Volunteer expressly and specifically assumes such risks.

PHOTOGRAPHIC RELEASE: Volunteer does hereby grant and convey unto Hadassah’s Hope all right, title, and interest in any and all photographic images and video or audio recordings made by Hadassah’s Hope during Volunteer’s participation in the Volunteer Activities, including, but not limited to any royalties, proceeds or other benefits derived from such photographs or recordings.

OTHER: Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that this Waiver and Release shall be governed by and interpreted in accordance with the laws of the State of Florida. Volunteer agrees that in the event that any clause or provision of this Waiver and Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Waiver and Release which shall continue to be enforceable.
