FIRST SESSION FOR PROMPT PAYMENT AND ADJUDICATION MECHANICS A SUCCESS!

On October 11, SABA held Ontario's first ever home builder and subcontractor session on the new Construction Act provisions that affect SABA member businesses. The following five best practices should be considered when agreements or contracts are entered into:

- 1. Holdbacks of 10% are statutory, not optional. It is a duty of each member of SABA to invoice according to the law and carry a 10% holdback provision from Owner all the way down to sub subcontractor
- 2. The law does not recognize supplier. All entities involved in the supply chain for a construction project where that entity would have rights to lien, are considered to be either contractors, subcontractors, or sub subcontractors. Suppliers are required to also be subject to holdback requirements.
- 3. Notices of Non-Payment are now mandatory in the event you do not pay a portion or all of a "proper invoice"
- 4. You cannot contract out of provisions of the new act. Any attempt to do so will mean the language is of no force or effect
- 5. Home builders that have title to the land, are considered to be Owners under the Act. All proper invoices received that comply with the Act, must be paid within 28 days or a notice of non-payment must be issued.
