- Contract is based off 52 total yearly services. Schedule day for service will be Wednesday-Friday weekly and Board will be notified if affected by weather. For any services missed, a credit in the amount of \$705.57 will be issued to NP HOA to be used towards additional services or credit on the regular monthly invoices.

EXTRA CHARGES NOT INCLUDED IN REGULAR BILLING :

***** ALL WORK MUST BE APPROVED BY BOARD IN WRITING BEFORE STARTING**

1. **PINESTRAW AND MULCH —**
 - A. **PINESTRAW IS INSTALLED AND DELIVERED AT \$7.85 PER BALE — CBE**
 - Pinestraw for entrance beds to be applied 1x yearly at 65-70 bales = \$549.50
 - Mulch to be installed 1 x yearly at 32 yards for Clubhouse beds and natural areas = \$2,400.00
2. **ANNUAL COLOR —**
 - A. **ANNUAL COLOR INSTALLED AND DELIVERED AT \$45.00 PER FLAT — 2 X YEARLY IN SPRING AND FALL ON SCHEDULE—**
 - Annual color to be installed at \$270.00 per install @ \$540.00 yearly.
 - Board will be notified of plant specifics before installation is completed. Estimating 10-12 flats total for the year.
3. **IRRIGATION STARTUP AND REPAIR —**
 - A. **BILLED AT \$90.00 PER HOUR FOR STARTUP OR REPAIR WHICH DOES NOT INCLUDE SUPPLIES FOR REPAIR.**
4. **OUT OF SCOPE TRIMMING OR CLEANUP WORK —**
 - A. **BILLED AT \$245 PER HOUR FOR 5 LABORERS PLUS ANY SUPPLIES NEEDED.**
5. **RETENTION POND SPRAYING TO BE COMPLETED 4 X YEARLY @ \$375.00 PER APPLICATION**
Clear chemical will be used during this application and not a Glyphosate (Round Up) mixture. SCHEDULE 1-APRIL, 1-JUNE, 1-AUGUST, 1-OCTOBER
6. **ADDITIONAL TRIMMING ON RETENTION POND DURING THE YEAR TO MAINTAIN A NORMAL LOOK —**
**** IF NEEDED: Will be billed at the normal cleanup rate of \$245.00 per hour for 5 laborers.**




