"The Eyes of Jesus"




"I will extol you, my God and King, and bless your name forever and ever..."

Psalm 145:1

"Hear O Israel: The Lord is our God, the Lord alone. You shall love the Lord your God with all your heart, and with all your soul and with all your might."

Deuteronomy 6:4-5





God's chosen people recite, usually by memory, Psalm 145:1-21 every morning as a part of their daily routine. (Nice way to wake up!) I recommend this practice wholeheartedly! And in the same Spirit that calls us out into life, our Jewish sisters and brothers have also routinely recited Deuteronomy 6:4-5, called the Shema, as they are about to leave this world that God has generously provided. Again, this end-of-life confession of faith is as awesome as it is familiar to the Jewish people who follow the one, living God. We have much to learn from our close cousins!

So the theme of this newsletter article is the inherent value of routinely making use of certain faith practices. As we continue to experience all that has been "exposed" by this global pandemic: worshipping God, including weddings and funerals, together, discussing God's hopeful, explosive word together, physically expressing joys and sorrows in homes and other public places, so much is missed AND NEEDED! Thank God for all the creative ways we've figured out to remain at least somewhat attached!

I maintain that in times like this, and there will always be times such as this, God calls us to make routine, certain faith practices that impact our immediate environment. Like you, I have a sense of being in exile, of feeling some pain because of our forced separateness. And like you, I wonder if there is actually more unexpected brokenness, community violence coming our way too. How is God calling Calvary to provide a community of grace to those who live in the midst of great upheaval? This is the exact time and place that I am advocating the deep necessity of routinely praying the Bible - from Psalm 145 to Deuteronomy 6 to the Gospel stories to other books of scripture (even Ecclesiastes and Lamentations for those who can handle it!) in order to listen and speak to others.

I believe both Calvary, and the community God has called us to serve, will benefit in unexpected ways because of this COVID-19's long-term presence. One important way of perceiving this benefit, this gift from God in the first place, is to routinely practice hearing just how God has done this reforming, this covenanting, in the past. It's right there in front of us as we open God's word that breathes God's Spirit so that we can listen and speak to others. It's an old, and truth be told, an odd story that promises to reveal God's renewing presence to us. Practice on!



Highlights of the CHURCH COUNCIL

Treasurer's Report - Overview

September 2020 August income was \$3,000 lower than the prior year. Each month there are gifts received that are annual, quarterly, or a family "catching up" or "paying ahead" that makes a difference on a monthly giving level. Calvary was able to offer three dates for drive-thru communion in August. About 50 people were served communion on each of the dates. Synod Assembly for the Eastern North Dakota Synod was held in the middle of August and a new bishop was elected. Backpacks were blessed at an outdoor worship service on August 30 for all those who have already begun or will begin school in the next couple weeks.

Year-to-date income through August was \$8,300 lower than the prior year and \$15,500 lower than the five-year average. Expenses year-to-date through August were \$22,000 lower than the prior year and \$17,600 lower than the five-year average. It is amazing even without in-house worship Calvary's members and friends continue to support Calvary at a comparable level to prior years. Thanks be to God!

Council Business

HVAC will be installed into the sanctuary by the end of October. The Calvary Constitution & Bylaws committee has been meeting in conjunction with the EaND synod office and are close to completing their review. The group has had good dicussion related to the size of the group and realigning council to not duplicate roles that may be on staff. We decided certainly many of the committees need to marchon, however the report out can be done possibly quarterly and not needing every committee chair or co-chair to be on council. The next step would be to call a congregation meeting sometime before the end of the year. Any changes to council structure would be facilitated through the Nominating Committee and carried out at the close of the congregation annual meeting. There have been no major changes that the group put forth other thancouncil/officer structure, really the goal is to put some defined roles and responsibilities to each member to make council as efficient and meaningful as possible.

Officers and Ministry Teams

Confirmation classes are in progress with registrations coming in for future classes. With the new program in place people can sign up at any time without the feeling that they are behind. There are going to be several services live-streamed for those affirming their baptisms this year. Each confirmand gets a few quests and there will be limited numbers at each service. Calvary worked with our internet provider and our IT company and streaming company this month to fix a few glitches with worship streaming. A portable sound board was purchased to be able to do outdoor worship with speakers and events in the parking lot. We are still working on this system to make it the best it can be but we have made good gains as far as audio quality. Going forward, congregation members may be getting a full newsletter at the beginnning of each month or a mini newsletter with follow-up mailings. Keeping Calvary updated with current information in print has posed a challenge due to the constantly changing environment. Be sure to subscribe to emails and check our social media pages if you have access! The church council is putting together a reopen plan which correlates more with Grand Forks County rankings than state rankings. It is a color-based system so people can know what safety measures we will take in different color categories. We will be reviewing the plan at the October 13 council meeting. This information, when finalized, will go out as a congregational mailing.
