## **NOTICE TO EXHIBITORS**

The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 24 hours, please telephone the Trial Secretary.

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the veterinarian, judge, or Trial Committee.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an\_act of a public enemy, or any other cause beyond the control of the organizing committee.

Entries must be made on Official AKC Entry Forms or copies and must include the signed Agreement and Rules. Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Post Dated and Returned checks do not constitute a valid entry fee. <u>There is a</u> \$35 returned check fee.

It is expressly understood that exhibitors alone <u>are responsible for the behavior of their dogs and/or children</u>. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

<u>Exhibitors are responsible for cleaning up after their dogs</u> at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The BCCA has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

All dogs must be on lead or crated at all times except when in the arena.

Dogs must wear a simple well-fitting buckle, snap lock, or slip collar (no tags) or may work without a collar at Trial levels.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date other than move ups. No refunds for duplicate entries.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

The Greater Plains Bearded Collie Club, their Board, Members, and RottiEwe Farm and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

The GPBCC does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

DOGS ON GROUNDS: You are responsible for picking up after your dogs and disposing of waste in the proper receptacles. All dogs present must be held on leash or otherwise restricted except when being judged. Under no circumstances will dogs be allowed to disturb resting stock or interfere outside the arena with another dog's performance in the arena. Un-entered dogs are not allowed in the trial areas.

PLEASE NOTE: Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**DECLINED ENTRIES:** The Bearded Collie Club of America may decline any entries and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim against the aforementioned club or any official thereof.

**ALTERNATE LIST POLICIES:** When entry limits are reached, all additional entries received prior to closing will be added to an alternates list. The alternates list will be used to fill vacancies that occur in the drawn running order, with the first available alternate entry replacing the first vacancy in the class entered. In Test Classes, alternates shall be given priority over dogs eligible to be moved-up.

**BITCHES IN SEASON** will be permitted to run but will be placed at the end of the running order in Test classes and in catalog order for Trial classes. Please notify the Trial Secretary before the beginning of the class if your bitch is in season.
