Cattle: Mixed-breed Angus and Charolais Cross, Market Value per head. There will be 3 head per run in all classes and on all courses.

Exhibitor will pay for any livestock injuries or replacement value in the event of death of any livestock caused by his/her dog. Exhibitor will pay the veterinary bill if the injury is slight.

#### **Entry Method**

**First Received with preference for Australian Shepherds**. All entries will be accepted on the opening date, but only entries for Australian Shepherds will be entered into the trial until March 25, 2024. All other entries will be put on a waiting list.

On March 25, 2024 at 6 pm CDT, those entries will be entered in the trial in the order received until the trial limits are reached.

You must waive the signature requirement for delivery services, if applicable.

A separate entry blank must be completed for each dog entered. Please use care in clearly indicating which days, classes, courses (A or B) and stock you wish to enter for each dog. Entries for a maximum of ten (10) dogs allowed in each envelope, regardless of the number of classes entered. Envelopes containing entries for more than ten dogs will be treated as invalid entries and returned.

Confirmation of entry will be sent via email if an email address is included on the entry form.

# **Dogs Eligible to Enter**

The May 15th trials are open to all Australian Shepherds nine (9) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP).

The May 16th trials are open to all AKC herding-eligible breeds nine (9) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or are approved Foundation Stock Service (FSS) breeds.

Wherever the word "dog" is used in these regulations, it includes both sexes.

#### **NOTICE TO EXHIBITORS**

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

The United States Australian Shepherd Association may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

The club will refund all but \$15 of the entry fee per day for dogs injured AFTER the closing date. Written requests for a refund must be made to the Trial Secretary no less than 30 minutes prior to each day's event start time. A veterinarian's letter must be provided stating when the injury occurred at the same time.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The United States Australian Shepherd Association has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. Include only AKC titles on entries.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

No refunds will be issued for overpayment of less than \$10.

Checks for pulled or unacceptable entries will be shredded. No checks will be returned.

The United States Australian Shepherd Association does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Exhibitors are responsible for cleaning up after their dogs. This includes properly disposing of waste and using designated relief areas

Children under the age of 12 must be accompanied by an adult at all times when on the grounds.

Weapons of any kind, illegal drugs, and fireworks are not permitted on the premises.

No selling of puppies or dogs on the premises.

All dogs must be on-leash at all times (except when crated or as required to be judged).

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies Vaccination Certificate - Missouri requires you to have proof of current rabies vaccination with you. Tags are not accepted.

Exhibitors accept personal liability with respect to any claim in respect to any damage or injury caused by their dog(s) in their possession

Move Ups must be turned in to the Trial Secretary, in wiriting, at least 30 minutes before the start of the trial.
