Entries for a maximum of ten (10) dogs are allowed in each envelope, regardless of the number of classes entered. Envelopes containing entries for more than ten dogs will be treated as invalid entries and returned.
Confirmation of entry will be sent via email if an email address is included on the entry form.

Livestock

Sheep: Katahdin Dorper cross. Value: \$300 per head. There will be 4-5 head per run for A and B courses.

Ducks: English Call. Value: \$75 per head. There will be 5 head per run.

Cattle: Angus & Cross. Value: \$2000 or current market value. There will be 3-5 head per run for A and B courses; 10 head per run for D course.

Exhibitor will pay replacement value in the event of death of any livestock caused by his/her dog. In the case of any injury to any stock caused by the dog entered, exhibitor will assume total responsibility for any damage and will pay the full market value of the injured animal in the case of serious injury or the veterinarian bill if the injury is slight.

Courses and maps will be posted one hour prior to the start of judging. A walk through with the judge will be conducted prior to the start of each class.

Event Details

Entries close Wednesday, March 4 at 6:00 pm CST. Drawing for run order will be held on Wednesday, March 4 at 7:30 pm CST at the Secretary's office.
Trial site will be available from 7:00 am to one half hour after the conclusion of the trial. Bring your own chair and water for your dog.
Lunch will be available for a nominal fee. There are also several nearby restaurants.
No unentered dogs are allowed on the trial grounds.

Moveups

Dogs shall be moved up to a higher class at the request of the owner, as a result of qualifying for a herding title, provided that the request is made to the Event Secretary no later than one-half hour before the start of the trial and that there are open runs available in the class. Email notice is acceptable.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from participation by action of the Event Committee, judge or veterinarian. The Saint Louis Herding Club may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the events cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the event site. In such case, no refund of any fees paid will be made.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement. Junior Handlers must enter their JH# on the entry form.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date/time. Errors in entries made by the exhibitor cannot be corrected after the closing date/time. No refunds for duplicate entries.

The event secretary is not responsible for entries or email communication not received.

Post-dated and returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

No refunds will be issued for overpayment of less than \$10.

Checks for pulled or unacceptable entries will be shredded. No checks will be returned.

Bitches in season will be permitted to run.

Entry fees will be refunded to alternates who decline to be placed on the alternate list. Entry fees of alternates who do not participate in the test will be refunded. Entry fees will not be refunded to a scheduled entrant who is absent on the day of the event unless an alternate is present and runs in the place of the absent dog.

Exhibitors are responsible for being at the ring gate when it is their turn to run. SLHC has no obligation or responsibility for providing a service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the gate when required.

All dogs must be on leash or crated at all times except when in the trial area. Dogs must wear a simple well-fitting buckle, snap-lock or slip collar (no tags) or may work without a collar at trial levels.

There will be a Port-A-Potty on site.

No alcohol is permitted on site.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

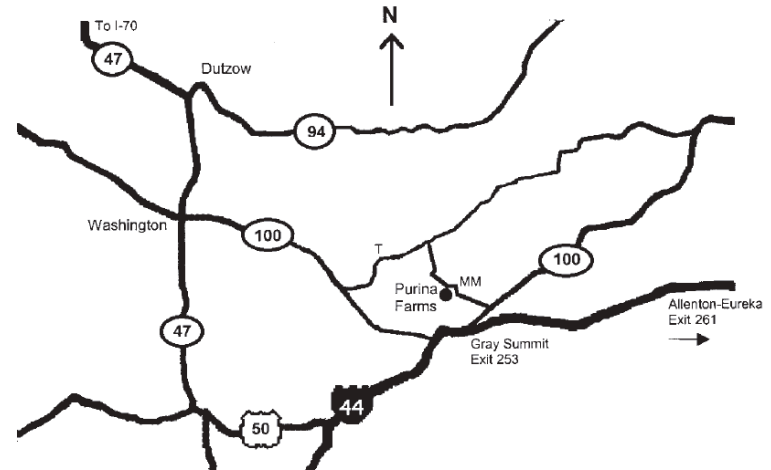
Saint Louis Herding Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Directions

From North/East/South: Take I-44 to Gray Summit/Hwy 100 Exit 253. Turn east on Hwy 100. After approximately ½ mile, turn left on MM at gas station. The herding fields are approximately ½ mile on left, just before the barn and entrance to Purina Farms.

From West: Take I-70 to Hwy 47, Exit 193. Take Hwy 47 south to Hwy 100. Continue on 100 to I-44 east. Take I-44 east one exit to Gray Summit. Follow directions above.
