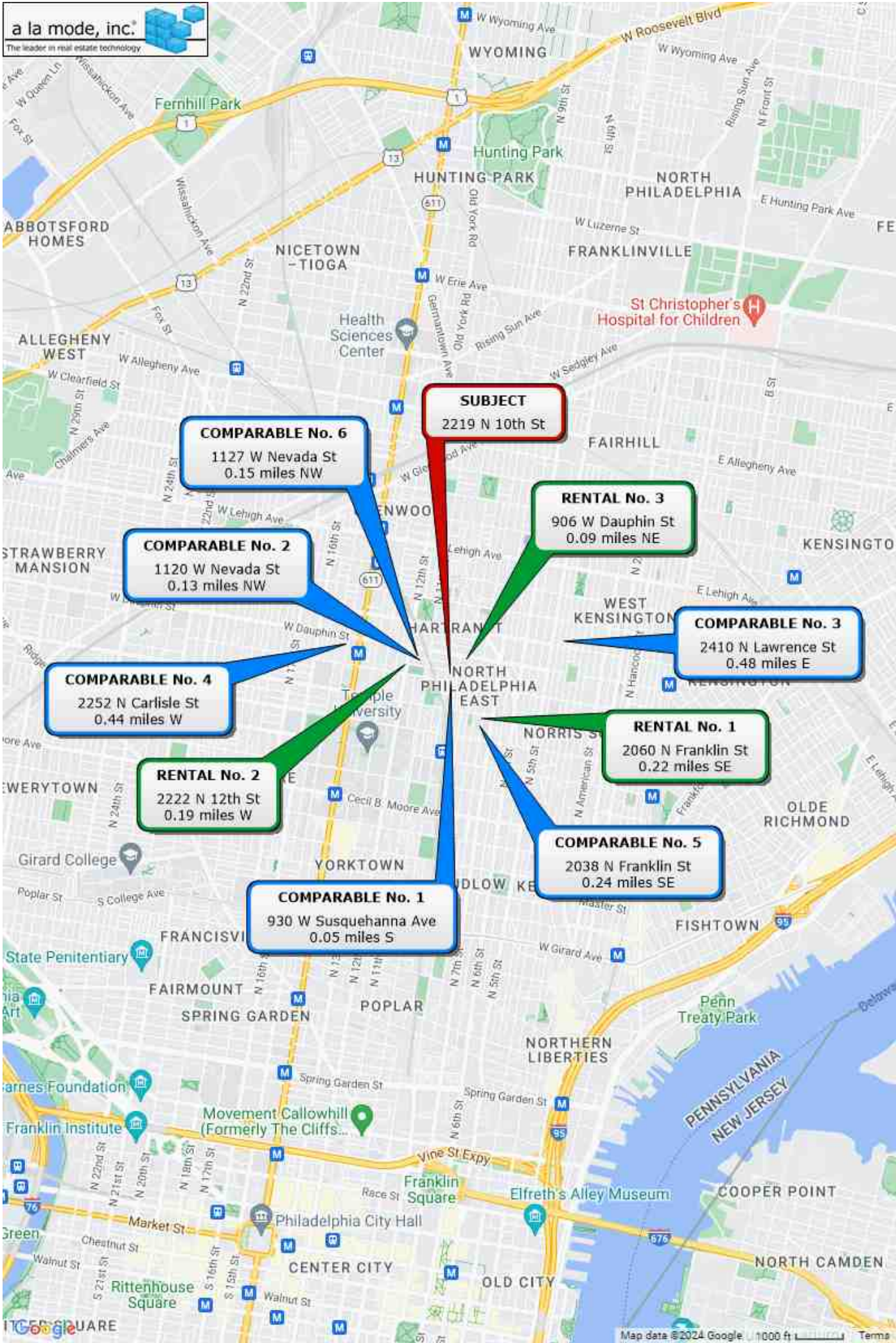

Condition Ratings and Definitions

C1

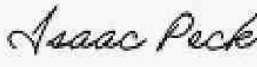
