Resonance, or "feeling felt," is our capacity to attune to the feeling states of others, and it represents the foundational way services are delivered at this practice. At Resonance, clinicians deeply understand and center the importance of relationships and authentic connection in the therapeutic healing space. In a society that values transactions over people, and in an industry (counseling) that often prioritizes behavior change over holistic mental health as evidence of success, many can overlook the importance of building safety and trust in the therapeutic relationship as an outcome itself (Badenoch, 2018). Furthermore, resonance, empathic attunement, and mirroring/reflecting can change the structure of our brains (Siegel, 2013) For Black, Indigenous, and Multiracial People of Color (BIMPOC), safety is often compromised by intentional or unintentional microaggressions in the therapeutic relationship when working with providers who do not have lived experience or deep implicit knowledge of cultural experiences that the client has or is currently facing.

Resonance's mission is to provide culturally specific and responsive therapy services that center the experiences and psychological safety of BIMPOC clients with intersectional identities and who experience cultural insecurity (gender and sexual minorities of color, neurodivergent folks of color, adoptees of color, multiracial and multiethnic folks, people of color raised in predominantly white cultural spaces, etc.). Resonance offers virtual (telehealth) mental health services for clients based in Oregon.
