As Kevin McCarthy, Speaker of the House, wakes up these days he has many unappealing priorities such as should I start to impeach Biden, should I shut down the government, should I take Donald Trump's phone call, why did I commit to Matt Gaetz and Marjorie Taylor Green's outlandish demands, and much more. And then add to that a request from other congressmen that he create a special committee that has subpoena powers to force disclosure about UFOs and aliens. What are odds that he will spend any time chasing UFOs and aliens? And, I have to rely on Kevin to help me win my \$100 bets that I made with some of you. Ugh.

In this update I want to give you further background about the recent explosive Congressional hearing that featured three whistleblowers including two military pilots and David Grusch a former member of the government group that was investigating UAPs. In particular, David Grusch made claims about



retrieved crashed UFOs, alien bodies, reengineering attempts and success, personal threats to his life and personal security, and that he can only disclose specific details in a top secret meeting location including who are the 40 other potential witnesses who have first hand evidence.

But first, I want to remind you why I am bothering to dig into this stuff again. After all, the recent allegations from Grusch have already been made by many other witnesses over the past 30 years! There is really nothing new here. What is new is that the environment has changed due to:

- Pentagon release of UAP tic tac and other videos in 2017
- former government and industry officials who are now talking openly about it - eg. Luis Elizondo, Chris Mellon and others including Steve Justice who was head of advanced systems at Lockheed Skunk Works
- legislation passed which demands disclosure of alien material, protection of whistleblowers, continued official UAP investigation and

- reporting of UAP examples to the public
- some Congress reps are determined to get to the bottom of the secret by holding hearings with whistleblowers
- pressure is building up in the Ufology community and the general public about the potential for real information about UFOs and aliens

So after many years of chasing the UFO rabbit down holes this is now the best chance in my lifetime for something to break open. But it can only be broken open by elected representatives in Congress or by some other unknown authority that causes disclosure.

The recent Congressional Hearing about UFOs was groundbreaking and was a direct result of new whistleblower legislation which was encouraging people to come forward with some protections that were never there before. The sub committee that did the hearing had to get permission from Kevin McCarthy to hold the hearing. There were supposed to be other witnesses attend who would have had first hand testimony (Grusch was second hand), but they

were pressured (ie threatened) by sources in the Pentagon not to testify (this is directly from the congress reps). In fact the Hearing room that was initially allocated for the hearing was under construction so live testimony would not happen.

After the hearing congress was denied permission to further interview Grusch in a secure location. In addition there was an unauthorized release of medical records about Grusch describing his PTSD conditions (he is an army vet), and drug and alcohol abuse in order to discredit his testimony. This medical information was fully known by the congress before his testimony and that did not stop them from interviewing him in public. It was said that a "release for information" request (which anybody can submit) was responsible for the leak, but the office that does the releases denies that any request was received. That means that somebody else in the government illegally released the medical records. Discrediting witnesses is a key pressure tactic that has been used many times in the past to stifle disclosure. Here we go again.

As a result of the denial to congress about interviewing Grusch again, the congress reps have asked Kevin McCarthy to create a new special committee because the original sub committee does not have subpoena authority.

However, any future interviews of Grusch or any of the 40 other first hand witnesses will all be held under a top secret classification. So although the congress will see and hear the details, as long as it remains top secret, the public will not be able to find out (except by illegal leaks - and who will be believe those?).

About the best we can expect is that an official government declaration will be made that could say that UFOs are real, we do have some crashed vehicles, some bodies were found but all other details will remain classified because there is a so called threat to our national security. The "threat" could be from our enemies who may want or have the technology already, and/or from the aliens themselves. So more more money will pour into the military industrial complex to defend us against our enemies and/or the aliens.
