I am again deviating from my intention to wait until definitive evidence comes out about the ET/UFO issue. However, today's second House Congressional Hearing is another big step towards that ultimate disclosure evidence.

It is remarkable that a bipartisan group of congress representatives have now been able to hold two public hearings about UAP's (new name for UFO's), one in July 2023 and another on Nov 13. I was surprised by the recent Hearing because of all of the focus on the recent election and thinking that it would be difficult to pull this off in this political environment.

The witnesses today supported many of the claims made by the witnesses in July 2023 and from a distance many of you will think that this is just "more of the same." It is not. In these two hearings you now have 7 witnesses who are all very credible with the most credible witness being Luis Elizondo, who I wrote to you about last time. Although the allegations are similar the weight of

evidence is increasing. Unless you study this in more detail you will be numb in realizing that the evidence is now becoming overwhelming. The evidence now includes some first hand testimony about crash retrievals and non human biologics although specific details still can't be disclosed due to security classification rules.

One of the more interesting comments that Elizondo makes is that he has not been given permission to talk about the crash retrieval program. So how can it make any sense that the government says you can't talk about a program unless that program does exist? He can say that it exists but not give any details. Isn't that, by itself, "proof" that we have crashed UFO's in our possession?

I urge you to read Elizondo's book as it has more factual evidence and proof than I ever expected - "Imminent: Inside the Pentagon's Hunt for UFOs".

Senate Hearing is now set for November 19 but it may not be all public information - which is a common problem with all of these hearings.

I am attaching the whistleblower (who is not yet public but going through the legal process) report that was tabled for the first time at the Hearing. It is a very technical read but illustrates the extent and depth of data that government has about UFO's that the Pentagon still will not admit to and

Although the Pentagon does admit that UFO's are real. Elizondo's book does a great job in explaining how this secrecy/denial process actually works within the Pentagon and Department of Defence.

I believe we are going into an accelerated period of disclosure which should break everything open within a year.
