Happy New Year!

I appreciate that most of you think that my emails highlighting what Steven Greer is predicting are ridiculous. I acknowledge that but what he is predicting is potentially the most important event in human history (my opinion, may not be yours). I have watched 3 or 4 of his interviews over the last couple of weeks and the latest one issued last night is attached. In every interview he has repeated his claim that before Trump's inauguration on January 20 a whistleblower group (described below) will come out. He has never made such a specific claim in his 34 year history of UFO coverage. He has also added extra details in each succeeding interview about what and how this disclosure is all about.



**In case it does happen** I want to do my own predictions around this potential event. To be realistic I think that the chance that the disclosure that Greer claims will happen soon is unlikely and he will lose any remaining followers over this risky prediction. But, the chance that the disclosure contemplated will happen eventually is 99% plus and likely

contemplated will happen eventually is 90 % plus and likely within a year.

First of all, what has Steven Greer predicted:

- in around 30 days (more or less by January 15) whistleblowers who have been working in 6 underground facilities in the US will announce who they are and what they have seen and done over many years
- the leader of this group has been involved in the illegal activities for 29 years and has risen to a senior position in the illegal group keeping things secret since the late 1950's when President Eisenhower lost control of this issue
- the leader and others did not realize that they have been working on illegal activities until recently
- they thought they were just working on secret black op special access projects which were secret, but still legal
- they are primary military green beret type individuals and aerospace contractors
- now knowing that their work was illegal they can no longer tolerate being involved in these profound secrets
- they are at risk of personal and family member death threats, especially while still being anonymous
- they approached Greer 19 months ago as Greer has a 30 year history of dealing with hundreds of whistleblowers and keeping their stories private until they are ready to come out
- they will unmask themselves (ie go public) and say that they have been involved in handling crashed UFOs, ET bodies, reengineering and making man made UFOs, electric magnetic pulse scalar weapons (which disrupt the electromagnetic fields around UFOs) and other amazing testimony
- they will be giving the public firsthand personal evidence

- they will be giving the public internal personal evidence along with definitive video evidence
- Greer is arranging a global distribution system for this evidence
- in anticipation of this event Greer has been meeting with representatives of the US government (including several Trump appointees) and the UK government to warn them about what will happen
- the group wants to come out before Trump's inauguration
- Greer and the group are expecting a massive disinformation campaign to discredit them and claim that it will just be an elaborate hoax

Ok, quite an amazing story. Is it fact or fiction? Will it happen or not? Let's review this.

Why it may be true and will happen?

- even though everything that will be disclosed is the same information that Greer has been claiming for over 30 years he has never before predicted a specific disclosure time period and he is aggressively promoting it
- as far as I am concerned if this does not happen Greer will lose any remaining credibility that he has (which may be little anyways) - his career will be over
- in two congressional hearings over the past two years there have been several whistleblowers most notably David Grusch and Luis Elizondo who have already testified under oath about similar claims, except that they are second/third hand witnesses
- other official whistleblowers have given similar first hand testimony to the Congress in private, most notably Michael Herrera who saw a man-made UFO in 2009

(Janet and I talked to him for 30 minutes when we were in California with Greer)

- millions of people around the world want this information to come out
- it may happen but won't be considered "true" because of the nature of the massive disinformation and discrediting process that will happen immediately - after all, if the video evidence is going to be the main evidence we all have seen before lots of hoaxed video especially with the use of AI

Why it won't happen?

- the whistleblowers will be killed or threatened to the point that they stop - Greer will presumably announce details of this if it happens
- the timing and implications around the new Trump administration transition may delay it significantly or stop it
- Greer is making the whole thing up and just trying to make money off of the related documentary that he has just released
- Greer will likely tell us to be a bit more patient and it will come out
- there appears to be a plan by either or both the government and the covert group covering up this secret to permit a slow deliberate integrative disclosure process to unfold which may override any other attempts at full disclosure by others

If it does happen here is how I think that it may come out:

- Greer will receive the disclosure information from the group

- the information will be immense and likely be stored on a private website
- Greer will either distribute links to the database, or initially, attach a few tantalizing details in an email
- Greer will also engage many podcasters to distribute the information
- if a database is used it will likely crash a lot
- various operatives in the secret military industrial complex including “regular” people in the government and major media will immediately deny the legitimacy of the whistleblowers and claim any videos are AI hoaxed
- the operatives will start to destroy, move or otherwise try and conceal evidence within the 6 underground facilities
- media such as NewNation and NewsMax will carry the information on their networks
- media such as CNN, ABC, CBS, MSNBC will initially totally ignore the event, or acknowledge it and engage their own “experts” to refute it
- eventually the sheer volume of the evidence and establishing the credibility of the whistleblowers will cause many people to pause and seriously consider the information
- the new Trump government will jump fully into this conspiracy and want to become the reason why it has been uncovered after 70 years
- the government will have congressional hearings to check further into this leading to subpoenas and search warrants for the 6 underground facilities
- other whistleblowers will start to pour out
- the mainstream media will jump fully into this now and we will be flooded by news investigations
- the rest of the people in the covert secret group will be given amnesty to come forward and disclose all
- after a few months the world will realize the truth of this

disclosure evidence

- as a society we will start to go through various stages of disbelief, denial, anger, acceptance and finally embracing the new facts of humanity and our place in the universe
- disclosure of some, but not all, of the ET technology will result in a huge opportunity to use the the technology for the benefit of the world
