Hi All

In this update I want to talk about the third objection to the reality of UFO's and aliens that I raised in update # 4, namely:

“Given the existence of cameras, and now phones, that everybody has why do we not have definitive photographic evidence, or other evidence of UFO's and aliens from the general public.”

I view this objection to be less of a problem compared to the previous objection about the military industrial complex. I believe that the amount and nature of the “evidence” that exists today is enormous. I have reviewed again “evidence” that I have seen before going back over 80 years. I now look at new evidence that has been unleashed by more witnesses and whistleblowers. New laws demanding alien material to be brought forward and protection of whistleblowers, government admission about the existence of UFO's, a reenergized and expanding

Ufology community is all flooding the news today.

If you want to search for UFO evidence (Youtube is the best place) you will see pages and pages of listings and 100's of hours of videos. I find that about half of what I see is crap including obvious hoaxes and misinformation, and half ranges from OK to excellent in terms of quality.

But I admit that we do not have a panel of independent and objective scientists who have done a rigorous scientific study of the evidence and issued a scientific opinion declaring that UFO's are real, aliens are real, they are here now, we have their crashed craft and their bodies, and we have been able to use some of the alien technology. However that does not mean that there is not compelling evidence out there. I will review the nature and quality of the evidence that we do have.

The kinds of evidence that does exist includes:

- photos
- videos including the Pentagon released tic

– tac and other videos

- thousands of credible witnesses, including police, military, every day people, abductees, pilots, politicians and more
- implants in abductees
- witnesses and whistleblowers who work in or have information about the military industrial complex and the evidence being covered up by that group
- radar evidence
- radiation evidence
- ground disturbances under landed UFO's
- meta materials (alien materials)
- ancient alien evidence including ancient writings, cave art, massive stone monuments, use of alien technology, ancient skeletal remains and more
- freedom of information requests in the US, UK and more
- a report by senior government officials and scientists in France
- paranormal and spiritually sensitive individuals who have communicated with aliens
- crop circles
- animal mutilations

- Skinwalker ranch
- CE5 contact
- and much more

Each category above will have a wide range of characteristics as to how credible the evidence is. There has also been a lot of proven hoaxes in each of the categories. Mistaken identity is very common as well.

Many books and documentaries exist that review a lot of the evidence in the above list. I don't want to bury you with information so I will select a few examples of what I think is the best evidence.

Although there are tens of thousands of photos and videos taken over the last 80 years some people wonder why the images are not crystal clear enough to “prove” that the image is a UFO. A number of comments about this:

- rarely are UFO's motionless for a long period of time
- if you have ever tried to photograph a moving object which is not close to you then you

know how difficult it can be to get a stable clear photograph

- in the rare moments when a UFO is stationary quite often observers find that all electronic devices near them including automobiles stop working until the UFO departs - this would be consistent with the view that UFO's are powered by extremely strong electromagnetic energies
- the other common time when observers are near stationary UFO's is during abduction experiences where paralysis and a period of lost time is experienced

I also want to clarify what UFO's actually look like. Yes, there are the classic flying saucers that are 10 to 20 feet in diameter. But there are UFO's that are as big as three football fields in length, the size of an aircraft carrier, flying pyramids the size of Egyptian pyramids, large triangular craft, spheres, large black V shaped craft, black spheres inside clear rectangles etc. But it is more common that they are small balls, light orbs and other small objects where you would wonder if they are even big enough to have an alien "pilot".

Given that the government has provided their own videos of UFOs and admit that they exist I believe that we do have 100% evidence now that they do exist. What needs to be clarified is who is responsible for them? It's either man, ET's, future time travelling humans, some unexplained phenomenon or some combination of these options. I continue to be less than 100% confident that the UFOs are man made, although there are many witnesses who claim it is true. If they are built by ET's or future humans then we need to look at the evidence supporting what kind of sentient beings are responsible for them.

So what is the evidence that aliens or future humans built these craft? There aren't any credible pictures or videos of aliens, either dead or alive. There are many eye witness testimonies from a variety of people including a nurse at Roswell, an Army Colonel, members of crash retrieval teams, and thousands of abductees.

One video has emerged recently about a captive

One video has emerged recently about a captive alien filmed in the early 1990's. The video is just over two minutes long although the story line goes on for awhile (you can jump ahead to see the actual video). It is bizarre and the guy talking about it looks like a con artist. But there is something intriguing about it.

In the 1990's a show about an alien autopsy became famous. It looked very authentic and a documentary made about it verified that the medical equipment and even the Kodak film used was genuine for the 1940's. The video producer who made it later admitted that it was a hoax. But he made it to recreate a real alien autopsy based on witness testimony.

Other than witnesses we don't have any definitive physical evidence of aliens. If we do get other first hand witnesses that come forward I don't know if that will be proof until the bodies can be scientifically examined.

Another area of alien proof is even more controversially and involves people who claim to have made contact with aliens primarily through

nave made contact with aliens primarily through telepathy and meditative practices. Whitley Strieber, the author of many books about his life long abduction and communication experiences, is very detailed about aliens and what they might be. Steven Greer who I have mentioned many times before developed a CE5 protocol in the 1990's. Before he became an emergency room medical doctor he was trained in meditation in Tibet. He uses groups of people to do group meditations and "summon" craft and aliens to interact with the group. He has videos and photos of UFOs appearing in the sky above the group and images of alien forms that appear near the group.

Some of the alleged evidence about aliens begs the question about what are the aliens like? Are they just more advanced and smart versions of human beings? Or have they evolved in a manner that is totally different from how humans behave and think? Can we compare ourselves to them or is it literally like us trying to compare ourselves to ants, bees and other forms of life

that has a form of intelligence but not how we understand intelligence. People who claim to understand them a bit will say that they operate on both a physical and telepathic/paranormal level. They are interdimensional beings who can pick up our thoughts in a non-local plane of consciousness (the same plane that may carry instantaneous communication in quantum entanglement) which is why they can pick up meditative thoughts from us.
