Late Happy New Year!

As a reminder, my recent more intense interest in my favourite topic, hobby and rabbit hole was triggered by the involvement of the US Congress in encouraging whistleblowers to come forward with protection, and having official public hearings to hear the new “evidence” about the UFO phenomenon. In reality, the information that has come forward is not new as the allegations have been made over the last few decades by unofficial whistleblowers (many of whom remained unnamed due to alleged fears about personal safety and security).

So there is now an added layer of credibility because people are giving testimony in private and a few in public, subject to perjury legal consequences if they are found to be lying. That is a big change. As a result, in a Congressional hearing last year we heard from three witnesses with the most revealing testimony coming from David Grusch. Congress originally had 12 witnesses scheduled to come forward but most of

witnesses scheduled to come forward but most of them were pressured not to talk by various players inside the Pentagon and the Department of Defense. That, by itself, is an interesting fact. Their failure to talk was very disappointing to the Congress because the details of their sworn testimony was already known, but is top secret and can't be publicly disclosed without their cooperation. As of now, they cannot be subpoenaed by Congress.

The David Grusch story:

- . had a top secret security clearance
- . was a US Air Force intelligence officer
- . was a DOD science and engineering technical advisor
- . was a senior geospatial intelligence officer
- . was senior technical advisor for the UAP/Trans- Medium issues (ie UFO)
- . as part of the government review of UAP's he was asked to investigate "black projects", where it was suspected that money was being spent on UFO related issues
- . as part of his role he interviewed 40 people who worked on black projects and concluded that:
 - UFO's are in "our" possession

- reverse engineering of alien technology is an ongoing activity
- non-human biologics are in our possession
- the Inspector General investigated Grusch's allegations and found them to be "credible and urgent"
- the 40 witnesses that Grusch interviewed have now been investigated by the Inspector General and testimony taken under oath
- shortly after his public testimony personal medical information was released illegally about his PTSD treatment as a way of discrediting him
- Grusch was threatened and has had to seek protection for his personal safety

So what is Congress doing now with this information? It is amazing to me that in the current political environment whereby Congress, especially the Republican party, can't accomplish anything, nevertheless some progress is being made, and in a completely harmonious bipartisan manner!

Following the hearing last year Congress wanted to be able to interview Grusch in a private, secure setting and issue subpoenas to many other witnesses including the 40 that Grusch

witnesses including the 40 that Gruson interviewed. Kevin McCarthy killed that (then lost his job).

Just a couple of weeks ago Congress did have a private meeting with the Inspector General to hear about the status of his investigation. He could not disclose details legally but was able to give the impression to Congress that has caused them to believe that their concerns about the allegations continue to be valid and that they will have more hearings in the future. In other words, there was no indication that the inspector General has dismissed the fundamental allegations. See video below.

As I said in the last update, the anticipated US legislation forcing disclosure of various UFO secrets and a six month timeline to provide access to UFO and alien materials was radically changed, primarily by the House Republican party.

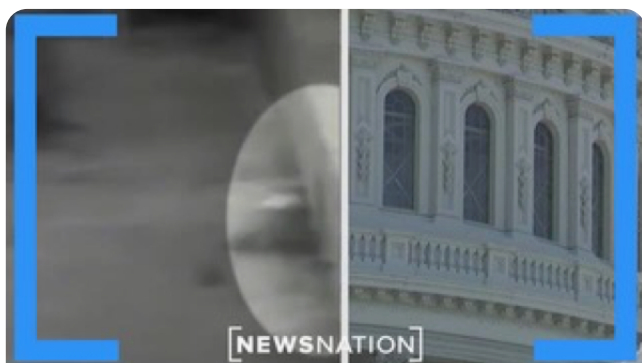
The legislation that was passed now gives the government and others 25 years to disclose. Not 6 months but 25 years! It is modelled after the JFK assassination legislation which still didn't release all of its information after decades.

Obviously something significant is being kept secret even though the existence of retrieved UFO's, alien bodies and reverse engineered craft has been denied by all government and aerospace contractors, but not under oath. The military industrial complex continues to stifle all attempts at disclosure.

Overall, I am optimistic as I see that pressure is building on many fronts to ultimately get evidence that most of us will be satisfied with about the reality of the UFO phenomenon.
