Hi All

In my last update I described the “Breaking News” represented by the Congressional Hearing which stems from legislation that is demanding regular updates from the Pentagon regarding UFO/UAP investigations now being “officially” being done by the government and the protection of whistleblowers who are aware of secret operations including possession of alien materials and any other illegal activities relating to black operations that are not sanctioned by Congress.

The hearing was notable because even if you don’t believe anything about UFO/UAP’s, potential recovered and reengineered UFO’s, alien bodies, etc all of the congress persons from both parties were totally in sync on this issue, asked great questions, showed respect to all 3 witnesses and each other, complimented each other and didn’t turn the hearing into a political slugfest. When is the last time that you could say that about any other congressional hearing? This doesn’t mean that they are drinking my cool aid, but that they take the issue seriously and want to get to real answers. Perhaps Reagan was right when he said at the UN that if the human race was faced with an alien threat then we would all rally together around the world. By the way, I do not believe that the aliens are an existential threat to us. In fact, quite the opposite.

The main whistleblower is David Grusch. First, what does it mean that he is a whistleblower? Is he just a witness to weird events and/or things he doesn’t like? No. In order to be a whistleblower under the specific legislation the following must exist:

- enter into a formal legal arrangement with the government
- he must be a witness to some law or laws being broken, not just snitching on juicy stuff
- if he lies he will go to jail
- his background is investigated to make sure that he has credibility
- this is no guarantee that he isn’t lying however

Grusch has top level security clearance based on his role in investigating UFO/UAP stuff. He is no longer working for the government but still has the clearances. With Pentagon approval he did a public interview with NewsNation a few weeks ago and repeated his testimony with Congress which is the first time ever that the Pentagon has authorized anyone to disclose what he did in both interviews such as:

- UFO’ exist
- we have several crashed UFO’s going back to the 1940’s
- alien bodies have been in some of the crashed UFO’s
- his life has been threatened and he was subject to intense intimidation
- the Inspector General is currently investigating the threats to his life and intimidation
- he obtained his information from over 40 other witnesses
- all names and details of the allegations have been submitted to the government for follow up

When he was asked to elaborate with more details about these claims he could not as he was restricted by the Pentagon not to publicly disclose secret classified information or he would face prosecution. However he said that if Congress gets permission to interview him in a top secret Sensitive Compartmented Information Facility called a skiff then he will provide them with the specific details. However, some congressman have already been denied a meeting in a skiff with Grusch.

In the next few months we will find out if Congress can question Grusch in a skiff. However this testimony will not be available to the public. I believe that pressure will increase to the point that the public will get more details about these allegations in due course.

So will this anticipated specific disclosure convince the public that crashed UFO's/alien body claims are finally proven? If somebody with direct contact with craft/aliens just says so, that is not enough. If they show you Iphone pictures of the craft/aliens that too won't be enough. Some of you may disagree and say that this will be enough - I may share that opinion but as has been said before "extraordinary claims require extraordinary evidence". There will need to be a comprehensive disclosure by the government with a display of craft/bodies and independent scientific review of the material for most people to believe it. What will you need to see to believe it?

My Prediction

I believe that within about two years (by July 31, 2025) that most people will see evidence that convinces them that:

- UFO's and aliens exist
- we have at least one alien UFO and one alien body (or parts thereof) in our possession
- there have been attempts to reverse engineer the UFO or other alien technology

In reality I believe that much more will be disclosed with proof but, for now, I will put money on the above. I am willing to enter into a friendly bet with anyone.
