

RULES

Show Committee has the right to combine and/or cancel any Class.

1. This show is run in accordance with the State 4-H Horse Show Rules.
2. Proper tack and attire shall be enforced in all classes. Boots and long sleeves are required for **all** classes and Properly fitted SASTM/SEI approved safety helmets with chin straps secured must be worn by **all** riders when mounted on the horse.
3. **Numbers to be worn on the rider's back or saddle pad and the same number will be used in all four shows. Each horse and rider combination must have a number.**
4. There will be a 2-minute time limit for entering the ring after the Class has been called. Exception: tack change, announcer must be informed. After the gate is closed, no rider shall be permitted into the ring.
5. Each horse can only be used once in each division of any event.
6. Horse and rider shall be one combination for all 4 shows of the circuit.
7. **Current negative coggins test is required as well as proof of a current rabies shot.**
8. The Show Committee has the right to ask any disorderly horse or rider to leave the grounds.
9. No alcoholic beverages permitted on the show grounds.
10. The County of Cumberland, Cumberland County 4-H and the 4-H Show Committee are not responsible for loss, damage or injury to equipment, horse, rider, or spectators.
11. No excessive use of force in Classes.
12. Points for each horse and rider combination shall count toward year-end awards in each class and each division. However, **a horse and rider combination must show in at least 3 shows to be eligible** for year-end awards and attend the Awards Banquet. **Show management will not be responsible for any awards not picked up at banquet.**
13. Choice of ribbon or fifty-cents for First-Six Place, Grand & Reserve in each Division, ribbons, and gifts. Riders must be present to receive gifts. **Prizes not picked up on day of show will be forfeited.**
14. Cloverbuds are not eligible for any other class. Riders in Cloverbud Grades K- 3 and under will not be judged; they receive **participation awards only**.
15. Walk/Trot riders must walk-trot only (will be disqualified for loping more than two steps).
16. **No horses allowed in food booth area, beyond horse barn area or in bleachers area.**
17. Stalls are available for \$10/day due at registration. Stalls must be cleaned before you leave.
18. **NO DOGS ALLOWED ON SHOW GROUNDS!**
19. ***In any timed event all arena gates MUST be fully closed before contestant start. The contestant is allowed a running start from within the arena after the gate is properly and completely closed. Exhibitors WILL NOT be allowed to enter or leave the ring if moving at a quick rate of speed.***
