Bylaw No. 2 ,2025


A bylaw to regulate and control the use and consumption of water from the waterworks system, to regulate and control the discharge of sewage into the sewage system, to fix the rates to be charged for the use and consumption of water, and to fix the rates to be charged for the use of the sewage system.

The Council of the Town of Sturgis, in the Province of Saskatchewan, enacts as follows:

1. This Bylaw shall be cited as "The Water and Sewer Bylaw".
2. In this Bylaw,
 - (a) "Town" means the Town of Sturgis
 - (b) "Administrator" means the Administrator of the Town of Sturgis.
3. Persons who want to be supplied with water from the Town's system must make application to the Administrator.
4. The charges to be paid by the water consumers, whose water service has been connected along with an infrastructure maintenance fee, shall be those set out in "Schedule "A" for water and "Schedule "D" for infrastructure maintenance fee attached to, and forming part of, this Bylaw.
5. The charges to be paid by persons who own, or occupy, premises drained, or that are by bylaw required to be drained, into the sewer are those set out in "Schedule B" attached to, and forming part of, this Bylaw.
6.
 - (a) Accounts for water and sewer shall cover a period of three successive months, and shall be rendered on, or before, the first day of the month next following such period. Accounts shall be paid within thirty days of the billing date.
 - (b) Where the water and sewer accounts remain unpaid after the thirty days in which the accounts were rendered, they shall be deemed in arrears and there shall be added thereto by the way of a penalty an amount equal to 3.95% per month on all unpaid water and sewer accounts.
7. If any rates or charges in arrears remain unpaid after 90 days, that amount may be added to, and thereby form part of, the taxes on the land or buildings with respect to which the service was provided.
8. Charges for bulk water shall be that as set out in Schedule "C" attached to form part of this Bylaw.
9. Bylaw No. 1, 2023 is hereby repealed.
10. "The rates, charges, tolls or rent contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee".

"SCHEDULE "D"

Quarterly Infrastructure Maintenance Fee:

A flat rate of \$30.00 per quarter or part thereof on any premises consuming water, whether metered or not, be charged to offset infrastructure maintenance costs.

Quarterly Recycling Maintenance Fee:

A flat rate of \$15.00 per quarter or part thereof on any premises consuming water, whether metered or not, be charged to offset recycling maintenance costs.

Proposed Landfill Decommissioning Fund:

A flat rate of \$30.00 per quarter or part thereof on any premises consuming water, whether metered or not, be charged to offset the landfill decommissioning costs.
