Late Fee

Please ensure your dog is dropped off on time for their appointment. If you are 15 minuets late with no notice you will be charged \$15. Anything after 20 minuets will result in a cancelation and rescheduling.

Care Fee

Clients are required to pick up their dogs in a timely manner. A care fee of \$15 will be added 30 minutes after receiving notice of when your dog will be ready. This fee is intended ensure that we can continue to provide timely services for all clients.

THIS FEE EXCLUDES TEACHERS AND LAW ENFORCEMENT

Deposit

In the event of 3 cancellations or no-shows, the client will be required to pay a deposit of \$25 for any future appointments. This deposit will be taken off the final total. THIS DEPOSIT WILL BE NON-REFUNDABLE and NON-NEGOTIABLE.

Cancellation policy

Clients must provide a minimum of 24 hours' notice for any cancellations to avoid receiving a fee. If a cancellation occurs on the same day, a fee of \$15 will be applied to cover the loss of income for the groomer. This policy is in place to ensure that time slots can be offered to other clients.

Liability

I understand that K9 Cuts by Emily will not be held liable for any injuries sustained by the client except in cases where such injuries are directly the result to gross negligence on behalf of the groomer. This liability ensures that K9 Cuts by Emily is only responsible for injuries resulting from severe and reckless misconduct.

Aggression

I understand that K9 Cuts by Emily has the right to refuse service at any moment. I am aware that if my dog shows signs of aggression and grooming becomes unsafe after trying different methods, K9 Cuts by Emily has the right to stop service and send the dog home unfinished. (Methods may include: muzzling and/or head cone.) I understand that I need to disclose aggressive behavior prior to scheduled appointment.

Senior Dogs

In the event that a senior dog exhibits signs of pain or discomfort related to aging during the grooming process, the groomer will prioritize the dog's comfort and well-being by providing a specialized comfort grooming service. This service may include: reduced grooming time, a shorter haircut or extra breaks during grooming. This is to ensure that the senior dog remains as comfortable and relaxed as possible while still receiving necessary grooming care. Any observations of discomfort will be documented and communicated to the owner to ensure ongoing awareness of the dog's health and needs. Your groomer will discuss this further at drop off.

De-matt and Undercoat

I understand that an extra fee will be added on due to excessive undercoat and/or matting. Extensive matting will result in a shave down and coat reset. I understand and assume responsibility for all pre-existing conditions and stress related incidents due to matting. Your groomer will discuss this further at drop off.

Vaccinations

I understand that K9 Cuts by Emily requires all dogs to be up to date on Rabies, Bordetella (kennel cough), and Distemper before entering the shop. I agree it is my responsibility to keep my dogs up to date on vaccines and disclose any health issues. I understand puppies need to have all puppy shots in order to start the grooming process. Please provide a copy if able to. I am aware that K9 cuts is not liable for kennel cough exposure.

Appointments

K9 Cuts by Emily is appointment based only. I understand that K9 Cuts by Emily does not offer same day appointments.

Injuries and Sickness

I am aware that if a trip to the emergency vet is needed, it is at the clients expense. Emergency vet used will be Red Barn Vet.

I understand if my dog is unmedicated due to aggression after the request was made, the dog will be sent home and not rescheduled until medicated. I understand that this is for the safety of my dog and the groomer from getting hurt.

Non-spayed females/ pregnant dogs

K9 Cuts by Emily will not accept non-spayed female dogs during their heat cycle, as this can lead to increased stress and anxiety for the individual dog. Additionally, the hormonal changes can result in heightened aggression during grooming sessions and may provoke disruptive behavior among other dogs in the facility. I understand that K9 Cuts by Emily will not accept pregnant dogs until puppies have been fully weaned from the mom as a safety precaution to mom and the pups.
